

SLSA GUEST - RELEASE OF LIABILITY

READ THIS FORM CAREFULLY- IT AFFECTS YOUR LEGAL RIGHTS

I ACKNOWLEDGE AND UNDERSTAND that (a) firearms, including rifles, shotguns and handguns, present inherent risks and dangers that may cause physical injury or loss of life; (b) the SANTA LUCIA SPORTSMAN'S ASSOCIATION (hereinafter "SLSA") located at 10400 Santa Clara Road, Atascadero, California 93423 owns and operates a shooting facility and gun ranges where firearms are present and used for shooting events, firearm training and target practice; and (c) I want to participate as a guest in activities at the SLSA shooting facility and gun ranges.

I am voluntarily participating in the activities and events at the shooting facility and gun ranges owned by SLSA. I understand that there are risks, such as physical and/or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability or even death, which may occur from my participation in or being present at these activities and events. These injuries or outcomes may arise from my own or other's actions, inactions, negligence, or from the condition of the activities location or the facilities. **In consideration for being allowed as a guest, I assume all related risks, whether known or unknown by me, caused by my participation in or being present at these events and activities.**

In consideration for being allowed as a guest to enter the premises owned and operated by SLSA, to use the shooting facility and gun ranges, and to handle firearms, I hereby release from liability and waive my right to maintain any action or to sue SLSA, its officers, directors, employees, and members from any and all claims and actions, including the negligence of SLSA, for any physical injury (including death), illness or economic loss that I may suffer while participating in or presence at any event or activity held at SLSA shooting facility.

I agree to hold SLSA harmless from any and all claims, loss or damage, including costs and attorneys' fees, suffered or incurred by any other person or entity and/or their property caused by my actions or inactions while on the premises or participating in the activities and events at the gun and shooting range.

I certify that as of this date, I (a) am a United States citizen over the age of eighteen (18); (b) of good character, law abiding and socially responsible; (c) may legally own a firearm under both Federal Law and the State of California; and (d) possess the physical, emotional and mental ability to safely use and handle a firearm.

I have read this document and signed it freely. I understand the legal consequences of signing this document, including (a) releasing SLSA from all liability, (b) waiver of my right to sue SLSA for any injuries or damages suffered, and (c) the assumption of all risks of participating in the events and activities held at the gun and shooting range.

I understand that this document is written to be as broad and inclusive as legally permitted by the State of California. I agree that if any portion is held invalid or unenforceable, I will continue to be bound by the remaining terms.
