- o Dormitory rooms are available at Base Camp Delta dormitory, which adjoins the Pigott Dining Hall. Each room has three bunk beds (up to six people). Private restrooms with showers are located in the hallway. A gathering room with television, tables, and chairs is located on each floor. Groups determine the number of rooms to rent based on desired occupancy (1 − 6 people) and group composition (male/female, youth/adult) to maintain BSA Youth Protection Guidelines.

Pre-registration and Check-in

All groups must register prior to trip, Check-in Sunday Only

Registrations after the deadlines below will be subject to the \$90 rate, do not wait to get a final head count from your group. Walk-ons will be welcome at check-in but reserve the bulk of your group in advance to lock in the sale price!

Reservations will only be taken in Black Pug.

Please have the **EQUIPMENT RENTAL AGREEMENT** and **SNOWTUBING RELEASE OF LIABILITY** filled out before checking in. **No "home-designed"** forms please! Leaders who attempt to submit another form will be asked to transcribe their group onto the form provided. **ONE FORM PER SCOUT.**

Your group must check-in on Sunday morning between <u>8:00 AM - 12 Noon</u>. Check-in is located in the building right next to the main ski lodge called Mickeys.

If you choose to snowboard you will let the staff know at the rental/equipment pickup.

Once you have been through the rental shop and received their equipment (ski or board), and later decide to change to the other. You will let the staff know at the rental/equipment pickup. They will charge you a fee of \$20 to switch and you will go through the cashiers at Winterplace.

SATURDAY NIGHT CHECK-IN IS NOT AVAILABLE.

What to pre-register for...

Basic Ski /Snowboard Packages: includes ski rental equipment (skis, helmets, boots & poles) & lift tickets, **Snowtubing, Damage Waiver** (covers damage to Ski Rental Equipment only), and **Meal Vouchers**

In order to receive the \$80.00 rate, your prepayments must be received in Black Pug on the deadline for your trip. Dates are listed on the left! Any packages purchased after the deadline for Winterplace will be subject to the \$90 rate.

Note: Any additions will be handled on Sunday morning at the Council check-in table.

Payment and Refund Policy

Full Refunds

Please be advised refunds on Council, District, or OA Events and Activities will be made only if an adult calls 10 days before the event to the Council Office to cancel that registration. The only exception to the policy will be the case of illness, accident and/or death in the family and that cancellation must be called in the day before the event. For cancellations made 10 days or fewer prior to the trip, a 5% cancellation fee will be applied.

Partial Refunds (One Per Group)

Partial refunds are only given when cancellations are made by 12 noon on Friday before the ski date. The refund request form must be either faxed or emailed to the Council Office before 12 noon on the Friday before the ski date.

Refunds will not be given for no shows. There will only be 1 refund per unit.

Refund requests submitted to the Council Office after the Friday before the ski day will not be considered. We will allow for a person to carry over his or her payment to another ski day. Once you have decided to roll-over credits, you cannot submit a refund request for those credits on a later trip. Credits are transferable to other families.

Rollovers

If your unit submits proper notice (see above) canceling its participation in one of the first two outings it has the option to roll-over its credit to a remaining 2025 date. If a unit intends to roll its credit over to another weekend, it must declare this intention before noon on the Friday before the trip it had been registered for. A new registration form is due for the future trip. Example: If you wish to roll over credit from the Jan. 12th trip to be used on the Jan. 26th trip your unit must declare that it wishes to cancel and rollover its credits by noon on Fri., Jan. 10th. Your unit would then submit a revised registration to the Council Office indicating the rollover credits by 5 p.m., Friday Jan. 10th. Anyone from a unit can use credits from anyone else in that unit who had earned them.

Inclement Weather Refunds

...will only be given if weather conditions cause the slopes to be closed. This almost never happens. Keep in mind Scouts must be responsible for lifting and tubing tickets and the clothes they attach them to. There will be no refund or replacement tickets if tickets are lost or misplaced. No replacement tickets are available without purchasing another.

<u>REMEMBER</u> THERE ARE 2 OPTIONS FOR CANCELLATIONS FOR THE FIRST TWO TRIPS: PARTIAL REFUND OR TRANSFER TO ANOTHER TRIP.

THERE IS ONLY ONE OPTION FOR THE LAST TRIP: PARTIAL REFUND ONLY

SNOWTUBING RELEASE OF LIABILITY

Please Read Carefully Before Signing

AGREEMENT

BECAUSE WINTERPLACE HAS ALLOWED ME AND (IF APPLICABLE) MINORS I AM RESPONSIBLE FOR ("MINORS") TO PARTICPATE IN SNOWTUBING, I AGREE THAT:

- 1. I WILL ACCEPT THE RISK of injuries or death while participating in snowtubing. These risks include injuries or death resulting from: (1) falls caused by or collisions with other persons, buildings, nets, fences, barriers, towers, poles, ditches, culverts, snowmobiles, groomers, lift components, snowmaking hydrants and other snow-making equipment, rocks, trees, limbs, branches, roots, stumps, ice, bare spots, and variations in terrain or snow conditions; (2) boarding, riding, or getting off a lift; and, (3) the negligence of Winterplace Ski Resort, NW Acquisition, LLC, and their owners, members, directors, officers, employees, agents, representatives, and insurers (collectively, "Winterplace"). I ALSO AGREE THAT I WILL EXPLAIN THESE RISKS TO MINORS BEFORE ALLOWING THEM TO PARTICIPATE.
- I WAIVE MY RIGHT TO SUE WINTERPLACE FOR, AND RELEASE WINTERPLACE FROM LIABILITY FOR DAMAGES, where the damages result from: (1) any of the risks described in paragraph 1 above; (2) my participation in snowtubing; and, (3) my responsibility for Minors' medical expenses.
- 3. I WILL INDEMNIFY, DEFEND AND HOLD WINTERPLACE HARMLESS IF: (1) Minors sue Winterplace for damages arising from the risks described in paragraph 1 above, or for Winterplace's negligence and, (2) any other third party sues Winterplace for damages arising from my participation, or the participation of Minors in snowtubing.
- 4. I ACCEPT A SNOW TUBE "AS IS" and will return it in the same condition as it was given to me, except for reasonable wear and tear. I will reimburse Winterplace for damage to the snow tube other than reasonable wear and tear while it is in my possession.
- I AND MINORS MUST FOLLOW ALL WRITTEN AND VERBAL INSTRUCTIONS. Failure to do so may result in revocation of privileges without refund.
- GOVERNING LAW: West Virginia law governs this agreement.
- COURT WHERE LAWSUIT MUST BE FILED: Any lawsuit against Winterplace arising out of my or Minor's participation in snowtubing must be filed in the Circuit Court of Raleigh County, WV.
- SEVERABILITY: If any part of this Agreement is found unlawful, it will be disregarded, and the remaining parts will be enforced.

IF YOU DO NOT AGREE TO ALL OF THE TERMS ABOVE, DO NOT SIGN IN THE SPACE PROVIDED. BY SIGNING IN THE SPACE PROVIDED YOU DEMONSTRATE YOUR INTENT TO BE BOUND BY THE TERMS OF THIS AGREEMENT.
