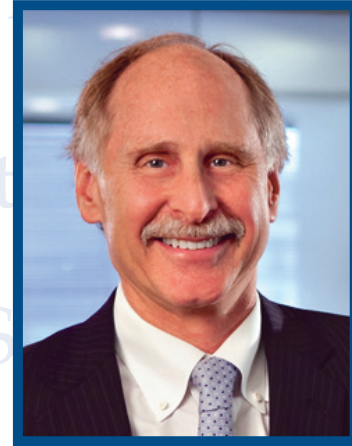

## **About the Honoree**

Robby Brewer has long been a business and civic leader in Montgomery County. 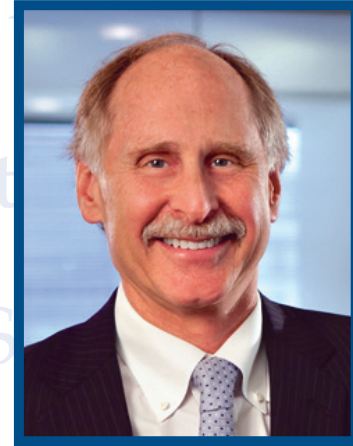
