How do those favorites sound to you? Have you ever heard any of them? Play three of your favorite songs for your relative, and explain why you like these songs. Ask what he or she thinks of your favorite music.</p> <p>(c) Serve for six months as a member of a school band, choir, or other organized musical group, or perform as a soloist in public six times.</p> <p>(d) List five people who are important in the history of American music and explain to your counselor why they continue to be influential.
