

Range and Target Sports Participation and Hold-Harmless Agreement

Archery

Scouts will have classroom and range instruction in how to handle, maintain, and use bows and arrows safely and how to increase their shooting skills. Scouts will shoot Archery under the supervision of a trained BSA Rangemaster Training or higher Archery Instructor.

Scouts will be required to always wear arm-guard and use finger protection while on the range. Scouts are expected to abide by all safety rules and the instructions.

BB Rifle

Scouts will have classroom and range instruction on how to handle, maintain, and shoot a BB Rifle safely and be provided instruction to increase their shooting skills. Scouts will fire a BB rifle under the supervision of a trained BB Rangemaster or NRA certified Rifle Instructor.

Scouts will be required to always wear eye and hearing protection while on the range. Scouts are expected to abide by all safety rules and the instructions.

Rifle

Scouts will have classroom instruction and range instruction on how to handle, maintain, and shoot a Rifle safely and be provided instruction to increase their shooting skills. They will fire a rifle under the supervision of a trained NRA Range Safety Officer and NRA certified Rifle Instructor.

Scouts will be required to always wear eye and hearing protection while on the range. Scouts are expected to abide by all safety rules and the instructions.

Shotgun

Scouts will have classroom instruction and range instruction on how to handle, maintain, and shoot a shotgun safely and be provided instruction to increase their shooting skills. They will fire a shotgun under the supervision of a trained NRA Range Safety Officer and NRA certified Shotgun Instructor.

Scouts will be required to always wear eye protection and hearing protection while on the range. Scouts are expected to abide by all safety rules and the instructions.

Black Powder

Scouts will have classroom instruction and range instruction on how to handle, maintain, load, and shoot a black Powder firearm safely and be provided instruction to increase their shooting skills. They will fire a black powder firearm under the supervision of a trained NRA Range Safety Officer and NRA Muzzleloading Instructor.

Scouts will be required to always wear eye protection and hearing protection while on the range. Scouts are expected to abide by all safety rules and the instructions.

Throwing Sports (Sling Shot, Hatchet, and Knife)

Scouts will be instructed on how to participate safely. They will be required to wear the appropriate safety equipment and follow instructions from the Rangemaster.

Pistol* – Scouts BSA, Venturers, Sea Scouts, and Adults Who Meet Specific Program requirements

Scouts will have classroom instruction and range instruction on how to handle, maintain, and shoot a pistol safely and be provided instruction to increase their marksmanship skills. They will fire a pistol under the supervision of a trained Range Safety Officer and NRA certified pistol instructor.

Scouts will be required to always wear eye protection and hearing protection while on the range. Scouts are expected to abide by all safety rules and the instructions.

Cowboy Action

Scouts will have classroom instruction and range instruction on how to handle, maintain, load, and shoot a cowboy action firearms (both pistols and rifles) safely and be provided instruction to increase their shooting skills. They will fire cowboy action firearms under the supervision of a trained NRA Range Safety Officer and NRA Cowboy Action Instructor.

If the child does not do the above, or is unable to participate safely, they will be removed from the program. I understand that any additional cost associated with participation in this program will not be refunded if my child is removed due to behavioral problems.
