TRAPSHOOTING WAIVER & RELEASE

IMPORTANT INFORMATION: The Naperville Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Naperville Park District continual strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors participating in this activity must recognize that there is an inherent risk of injury when choosing to participate in recreational activities.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

WARNING OF RISK: Trapshooting is intended to challenge and engage the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury. All hazards and dangers cannot be foreseen. The very nature of trapshooting is risky, including but not limited to, unsafe gun handling, poor shooting skills and techniques, recklessness and horseplay, unauthorized people moving onto the shooting range, flying objects such as ejecting shells and broken target pieces, discarded empty shells on the ground, premises defects, self-inflicted wounds, acts of God, inclement weather, inadequate or defective equipment, failure in supervision or instruction, horseplay, carelessness, walking into the line of fire, and all other circumstances inherent to sport of Trapshooting. In this regard, it is impossible to guarantee absolute safety.

PHOTO/VIDEO POLICY AND WARNING: Photos and video footage are periodically taken of people participating in a Park District program or activity, attending a class or event, or using District facilities or property. Please be aware that by registering for a program or class, participating in an activity, attending an event, or using District facilities or property, you authorize the District to use these photos and video footage for promotional purposes in District publications, advertising, marketing materials, brochures, event flyers, social media (including Facebook, YouTube, Instagram, Twitter, and other social media sites operated by the District), and the District's website without additional prior notice or permission and without any compensation to you. All photos and videos are property of the District.

Please read this form carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity (including transportation services and vehicle operations, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the Naperville Park District including its officials, agents, volunteers and employees.

I hereby acknowledge that I am aware that users of Sportsman's Park trap range may only discharge at this facility shells specifically containing only steel shot, and that the use of "non-target type" shotgun shells and/or shells containing lead pellets or any other substance is strictly prohibited by the rules of the Naperville Park District, and by state and federal environmental laws. I hereby swear and affirm under penalty of perjury that I will not bring onto the range, nor discharge at the range, shotgun shells containing lead shot or any other substance other than steel shot and will use only "target type" with "load equivalents" for the purpose of "target practice". By entering this facility I hereby agree to submit to a search of my person and any containers I carry onto the range to assure my compliance with this rule, and understand that if any "non-target" shells or any shells containing shot other than steel are discovered during a search they shall be confiscated by the Naperville Park District or Naperville Sportsman's Club representative.
