PARENT AND LEADER GUIDE

The Programming is included in the Three Fires Council Activity Fee. There is a \$10 rental fee for the use of Rainbow Scout Reservation per person. Per Three Fires Council Activity Fee guidelines, units who register on-time are not charged an additional fee.

CANCELLATION POLICY

The camper fee refund policy is established by the volunteer TFC Camping Committee.

*Refunds within 30 days of a camp session may be considered only in the case of an emergency such as an injury, illness, or death in the family.

*No refunds will be made if requested after the first day of the camp session.



REGISTRATION

This program is intended for Scouting age youth, ages 5-17, with age-appropriate Activities per the BSA's Guide to Safe Scouting. All youth participating must be between the ages of 5-17. Each youth registration covers: a patch, access to activities and vendors offered, and prizes. Each adult registration covers: event costs and patches while supplies last.

YOUTH PROTECTION LEADERSHIP & TRAINING REQUIREMENTS:

- **Scouts BSA/Venture Crews/Sea Scouts:** Ensure that enough leaders from your unit are attending. Your unit **MUST** meet the following requirements:
 - Two leaders from your unit must always be present with your Scouts (two-deep leadership)
 - If you have female Scouts, then a registered female leader must also be present.
- **Cub Scout Packs:** Scouts camping as a unit must attend and tent with a parent or guardian **AND be Cub Scout Age** (family camping). Lion and Tiger Scouts must have a parent attending with the Scout.
 - Each Cub Scout Pack must have at least one adult present that is BALOO trained.

BEFORE ARRIVING AT CAMP

- **MEDICAL FORM COPIES**
 - Collect a copy of your Annual BSA Medical Form **Parts A&B** completed for every camper (youth and adult). **Medical forms will not be returned and will be shredded after the event.**
 - Medical forms must include a photocopy (front and back side) of each camper's insurance card and attach it to the back of their medical form.
 - Make copies of each medical form. Keep the originals. Copies will be shredded.

- **Additional Medical Form Part A must be turned in to participate in Climbing and Range & Target Sports.**
- **All participants, whether unit or family, are responsible for bringing their own meals**

EMERGENCY PHONE NUMBER

Rainbow Scout Reservation (RSR) does not have a monitored phone line during events. If you have an emergency, please contact a leader from your unit. If you are unable to contact a leader, you may reach out to anyone listed in the contact section above.

LOST AND FOUND

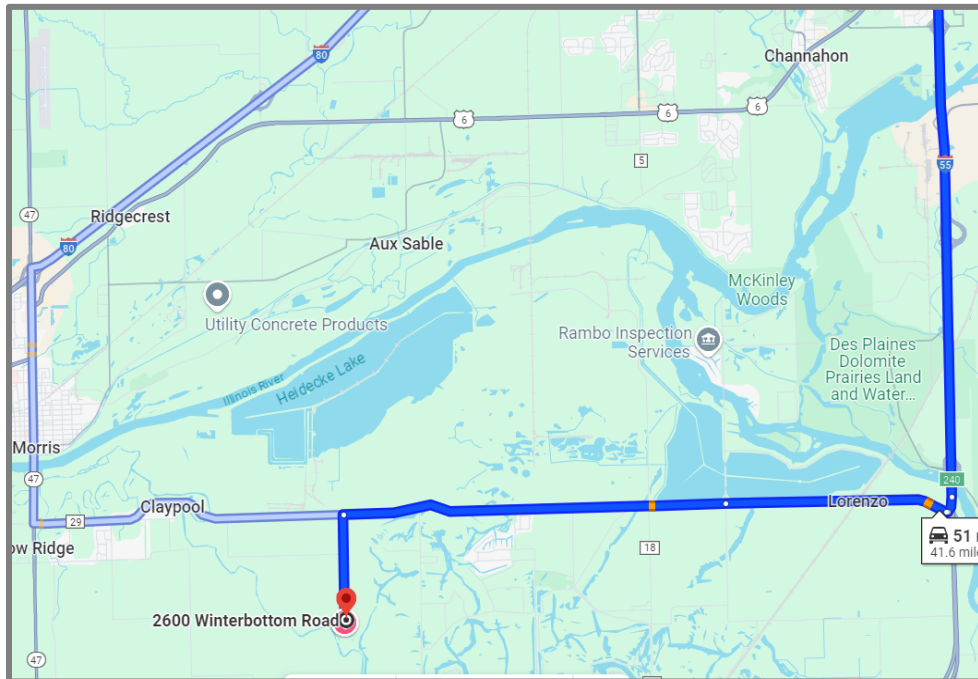
A lost and found is maintained in the Camp Office. If you have found an item without an owner, bring it to the Camp Office. Any unclaimed items will be transported to the Norris Service Center (415 North 2nd Street, St. Charles, Illinois) and retained for 30 days.

TRAVELING TO CAMP

Rainbow Scout Reservation is in Morris, just south of the Dresden Power Plant. If coming via route 55, take exit 240 and follow the road until needing to turn into camp. If coming in via route 80 or 47, turn on Pine Bluff and follow the road until needing to turn into camp.

Motor vehicles are to be parked in the areas provided - either the main parking lot or the overflow parking lot located just west of the main entrance to camp. The speed limit is **5 miles per hour**. Vehicles are not permitted in the camping areas except under the particulars of the unit gear trailer section. See more info under Trailers.

We highly encourage unit carpooling.



Program Overview

OVERVIEW OF CAMPOREE

This Camporee is designed for youth ages 5-17. Cub Scout Packs will camp in a designated Cub Scout Camping Zone.

MEALS AND WATER

- All meals are the responsibility of each unit/camper and are to be cooked in their own campsites. No supplies will be provided by the Camporee Staff. No hot/cold food service is planned for this event. Saturday 'day-participants' are encouraged to bring their meal(s) in a small backpack.
- All participants should bring a water bottle/Nalgene which can be refilled at camp.

FIRES AND FIREWOOD

- Campsites must use a pre-made fire area. Do not create a new fire pit. Per the Guide to Safe Scouting, liquid flame starters are prohibited and absolutely no flames are allowed in tents. All units should have a fireguard schedule posted in their campsite. A blank copy is attached to this booklet.
- Build campfires in existing fire pits and put out all fires with water. Do not dig holes or create new burn locations for fires. Fires may be prohibited due to weather conditions.
- There usually is pre-cut firewood available in campsites; please do not bring in outside wood.
- If scavenging for wood in the campsite, please remember the "Four D's": Dead, Down, Dinky, Dispersed. Do not chop down trees or branches. Axes may be used in troop-established axe yards under adult supervision.

RESTROOMS

Within each campsite is an outhouse. Near the center of camp is the SR building which has flush toilets and showers.

CLIMBING SAFETY REQUIREMENTS

Clothing rules are for safety

- Long pants preferred
 - NO NYLON SHORTS (*Harnesses are nylon. Nylon on nylon is slippery*)
- Gym shoes or hiking boots
 - NO CROCS, SANDALS, WATER SHOES, MOCCASINS, MOON BOOTS, ETC
- Shirts tucked in
- NO HOODIES. Alternate for cooler weather. Hoods will be required to be tucked in if worn.
- NO JEWELRY
- Long hair tied up
- No large belt buckles
- Glasses must stay on.
- You will be asked to empty your pockets.

Please come prepared wearing appropriate clothing and shoes. No one likes to disappoint Scouts, please communicate these clothing requirements.

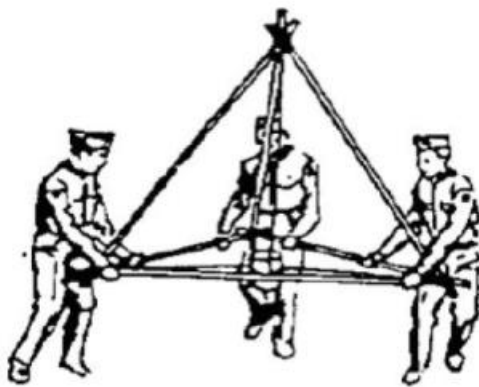
PIONEERING CHALLENGE ACTIVITY

Nitro Transporter Relay

Group of 3 - 4

Construct a transporter to safely transport nitro, then attempt to transport it without detonating. This will be a fun, timed, challenge where you will lash together 6 with 7 lashing ropes and then transport the nitro through the course laid out and tear your transporter back apart. Time begins at assembly and ends will all parts disassembled and neatly pile back together.

SCOUT Golden Skillet Competition - Special Cooking Competition to win the Golden Skillet

This is a special cooking competition that will take place on Saturday evening. The first, second, and third place awards win the Golden Skillet, the Silver Skillet and the Bronze Skillet respectively.

To enter: Bring one large serving (which the judges will divide up into small samples) of the dish that you wish to enter to the designated area in the [Wilhelm Center between 5:30 PM and 6:30 PM](#).

To be eligible, the dish must be:

- Fully prepared in camp from very basic or raw ingredients
- Part of your own menu for that evening
- Cooked by the Scouts.

The judges will ask the delivery person about the preparation details. Judging will be based on numerous factors including taste and degree of outdoor cooking skills represented.

LEADER Golden Spoon DESSERT Competition – New competition for Unit Leaders

This is a special dessert competition that will occur Saturday during Lunch. The first, second, and third place awards win the Golden Spoon, the Silver Spoon, and the Bronze Spoon respectively.

To enter: Bring a large dessert serving (which the judges will divide up into small samples) to enter to the designated area in the [Wilhelm Center between 5:30 PM and 6:30 PM](#)

To be eligible, the dish must be:

- Fully prepared in camp from very basic or raw ingredients

Judging will be based on numerous factors including taste and degree of outdoor cooking skills represented.

ADDITIONAL POLICIES

1. The Scout Oath and Law are the codes of conduct for behavior expected at Rainbow Scout Reservation.
2. Youth Protection guidelines must always be followed by youth and adults. Review Youth Protection guidelines before attending camp. <https://www.scouting.org/training/youth-protection/>
3. Parents and unit leaders are always accountable for their Scouts. A headcount should be taken before and after any time your Scouts move as a group. The buddy system should always be followed.
4. While at camp all Scouts, leaders, and parents must wear a wristband provided during check-in.
5. Closed-toed and closed heeled shoes and socks must always be worn, except when in a tent.
6. Under no circumstances is an open flame to be used inside a tent. Lanterns (except those that are battery operated), candles, etc., are not allowed in any tent.
7. Pets are not permitted; official service animals are welcomed (please let administration know).
8. Rainbow Scout Reservation is a NON-SMOKING facility. Smoking will be limited to SPECIFICALLY designated areas. Violators will be asked to leave the property.
9. Cub Scout Packs are required to have at least one BALOO trained leader present.
10. Lion and Tiger parents are required to attend and travel with their Scout.
11. Personal vehicles are not allowed on camp roads at any time except as noted for unit gear trailers.
12. Report all injuries on camp property to the Camp Office/First Aid.
13. Report any damage or breakage of camp facilities or equipment to camp staff as soon as possible.
14. Do not enter or pass through another group's site or the staff site without permission.
15. No standing tree, living or dead, may be cut down without the permission of the Camp Ranger.
16. Campers and adult leaders are responsible for policing their campsites and leaving their areas clean.
17. Everyone – campers, leaders, and staff – must sign-in and sign-out of camp when leaving the property. The sign-in and sign-out form will be in the Camp Office.
18. Do not climb over, lean against, or sit on fences in camp. Respect camp boundaries. Do not cross fences or other obstacles onto private property.
19. Do not tamper with smoke detectors, fire extinguishers, or other emergency or lifesaving equipment.
20. Alcoholic beverages, illegal drugs (including marijuana), fireworks, or firearms are not permitted in camp. Vandalism, theft, personal injury or other illegal actions will not be tolerated. Local authorities will be called, and damages will be assessed.
21. Food should be stored in animal-proof containers and maintained at proper temperatures. Families are responsible for the safe storage of all food brought by them to camp.
22. Discipline at camp is the responsibility of unit leaders and parents. The adult members of the camp staff are available to assist when necessary. Corporal punishment is not tolerated.

Arrival and Check-In Process

ARRIVAL TIMES

- **FRIDAY CAMPERS** – Plan to arrive AFTER 6:30 pm. Check in is at the Camp Office located at the east end of the parking lot. **Each participant will turn in a copy of their Medical Form, parts A+B.** Upon checking in participants will receive their wristband and paperwork (map, schedule, etc.).
- **SATURDAY ARRIVALS** - Check-in begins at 7:00 am in preparation for Opening Flags at 8:45 am. Saturday campers can set up their campsites after 7 am check-in or during lunch. Check-in is at the Camp Office located at the east end of the parking lot. Each participant will turn in a copy of their Medical Form, parts A+B. Upon checking in participants will receive their wristband and paperwork (map, schedule, etc.).

PARKING & GEAR

Participants will be directed where to park.

IMPORTANT: No vehicles will be allowed in the camp area, so units must be prepared to move their gear on their own from the main parking lot to their assigned campsite. There are no carts available at Rainbow. **IT IS RECOMMENDED TO BRING A PERSONAL/UNIT WAGON.**

TRAILERS AT CAMPSITE

One detachable troop trailer per troop, may be brought in and parked near your campsite. The tow vehicle must be immediately detached and returned to the main parking area. Trailers require escorting to their campsite, so plan for extra time. **This trailer may not leave until the entire unit is leaving. Please contact Staff to request an escort for safety: Kristine 630-699-4754 or Andrea 630-780-7891.**

Units that are camping with 8 or more registered that do not have a troop trailer may request a pass in advance to have one gear vehicle (a van or smaller) which may be parked near their campsite. **This trailer may not leave until the entire unit is leaving. Please contact Staff to request an escort for safety: Kristine 630-699-4754 or Andrea 630-780-7891.

Check-out: Upon departure, leaders will check-out their unit at the Camp Office where they will receive their event patches. **Medical forms will not be returned.**

Youth Protection Policy

SCOUTING'S BARRIERS TO ABUSE

Scouting America has adopted the following policies for the safety and well-being of its members. These policies are in place to protect youth members and adult leaders. All parents and caregivers should understand that our leaders must abide by these safeguards.

Scouts First Helpline 1-844-SCOUTS1 (1-844-726-8871)

As part of its "Scouts First" approach to the protection and safety of youth, Scouting America has established a dedicated 24-hour helpline to receive reports of known or suspected abuse or behavior that might put a youth at risk. **If someone is at immediate risk of harm, always call 911.** Use the helpline if you believe a youth has been harmed or their safety is at risk, you can't reach your Scout executive or local council, or if bullying related to race, religion, sexual orientation, or disability isn't resolved locally.

POLICY REMINDERS RELATED TO CAMP

- One-on-one contact between adult leaders and youth members is prohibited.
- Communication by way of social media (Facebook, Snapchat, etc.) must include another registered leader or parent.
- Discipline must be constructive and reflect Scouting's values - corporal punishment is never permitted.
- Disciplinary activities involving isolation, humiliation, or ridicule are also prohibited.
- Leaders must ensure all participating in Scouting activities abide by the Scout Oath and Scout Law.
- Adult leaders and youth members share the responsibility for the safety of all participants in the program, including adherence to Youth Protection and health and safety policies.
- Adult leaders are responsible for monitoring behavior and intervening when necessary.
- Physical violence, sexual activity, emotional abuse, spiritual abuse, unauthorized weapons, hazing, discrimination, harassment, initiation rites, bullying, cyberbullying, theft, verbal insults, drugs, alcohol, and pornography have no place in the Scouting program and may result in revocation of membership.
- All leaders are required to adhere to the Scouter Code of Conduct

RESTROOMS

- Separate restroom facilities will be provided for male and female adults as well as for male and female youth. If separate facilities are not available, separate times should be scheduled and posted.
- Privacy of youth is respected.
- Adults and youth must respect each other's privacy, especially in situations such as changing clothes and using restroom facilities at camp.
- Adults and staff should closely monitor these areas but only enter as needed for youth protection or health and safety reasons.

PROGRAM REQUIREMENTS

- The use of smartphones, cameras, mirrors, drones, etc., in places or situations where privacy is expected is prohibited.
- All aspects of the Scouting program are open to observation by parents and leaders.
- Scouting America does not recognize any secret organizations as part of its program.
- Hazing and initiations are prohibited and have no part during any Scouting activity.
- All persons participating in Scouting programs are mandated reporters of child abuse.
- Reports must be made to local law enforcement and child protective services. This reporting duty cannot be delegated to any other person.
- Reporting to the Scout executive or Scouts First Helpline ensures that follow-up can occur for the safety of our youth. Scout executives and Scouts First coordinate follow-up actions.
- All forms of bullying and harassment including verbal, physical, and cyberbullying are prohibited.
- Inappropriate public displays of affection are prohibited.
- Sexual activity is prohibited.
- Appropriate attire is required for all activities.
- Serious Youth Protection policy violations or behaviors that put a youth's safety at risk must be reported to the Scout executive.

Additional Health and Safety

BEFORE ARRIVING AT CAMP

- Have the BSA Annual Health and Medical Record Parts A and B completed for every camper (youth and adult). This is mandatory for everyone attending.
- Make a photocopy (front and back side) of each camper's insurance card and attach it to the back of their medical form. Make copies of each medical form. Keep the originals.
- Ensure all medicine is in its original container and clearly labeled with the patient's name, dosage, and expiration date. Keep these in an easily accessible area during the check-in process as the health officer will review and document them.
- Arrange for and pack the equipment that you will need at your campsite. For more information, refer to the suggested packing list in this guide.

ANNUAL BSA HEALTH AND MEDICAL RECORD (PARTS A AND B)

Every youth and adult attending camp MUST turn in a Medical Form upon check-in. Please turn in a copy and keep the original for your personal records. A photocopy of both sides of your insurance card MUST be attached to the medical form. Please use the most current version of the Scouting America Annual Health and Medical Record (form #680-001). MEDICATION

All medication prescribed to campers or adults should be taken while at camp. All medications brought to camp by a camper shall be in containers that are labeled to include their name, the name of the medication, dosage, frequency of administration, and route of administration. All medications listed on medical forms should be readily available during the check-in process and given to an appointed member, either a leader from the unit (older scout programs) or parent (cub scout). Allergy kits, EpiPens, inhalers, and other instant self-administered life-saving medications should be carried by the individual prescribed to, including those under 18 years of age. Parents should be aware of the location of all life-saving medications.

MEDICAL INFORMATION

Medical policies are set by the National Council of Scouting America and the State of Illinois. Compliance with the policies regarding the completion of the health forms is mandatory. Due to federal regulations (HIPAA), copies of these health forms should not be sent digitally prior to the event.

ALCOHOL, TOBACCO, AND DRUG USE

Leaders should support the attitude that they, as well as youth, are better off without tobacco in any form and should not use these products at any Scouting activity. This includes the use of electronic cigarettes, personal vaporizers, or electronic nicotine delivery systems that simulate tobacco smoking. Designated areas will be made available for tobacco product use. Please confirm the locations of acceptable use upon check-in. As outlined in the Scout Code of Conduct, Scouting activities are not a place to possess, distribute, transport, consume, or use any of the following items prohibited by law or in violation of any Scouting policies: alcoholic beverages or controlled substances, including marijuana. In addition, the Code of Conduct specifies that if you are taking prescription medications with the potential of impairing any functioning or judgment, you will not engage in activities that would put Scouts at risk, including driving or operating equipment.

APPENDIX 1: FALL COOKIE COMPETITION ENTRY FORM

1st place will be awarded for both Cub Scouts age & older program entries for both themes

OFFICIAL RULES:

1. Contest is intended for amateur bakers only.
2. No store-bought dough or cookies. Cookies must be prepared by the person entering and may be prepared at home.

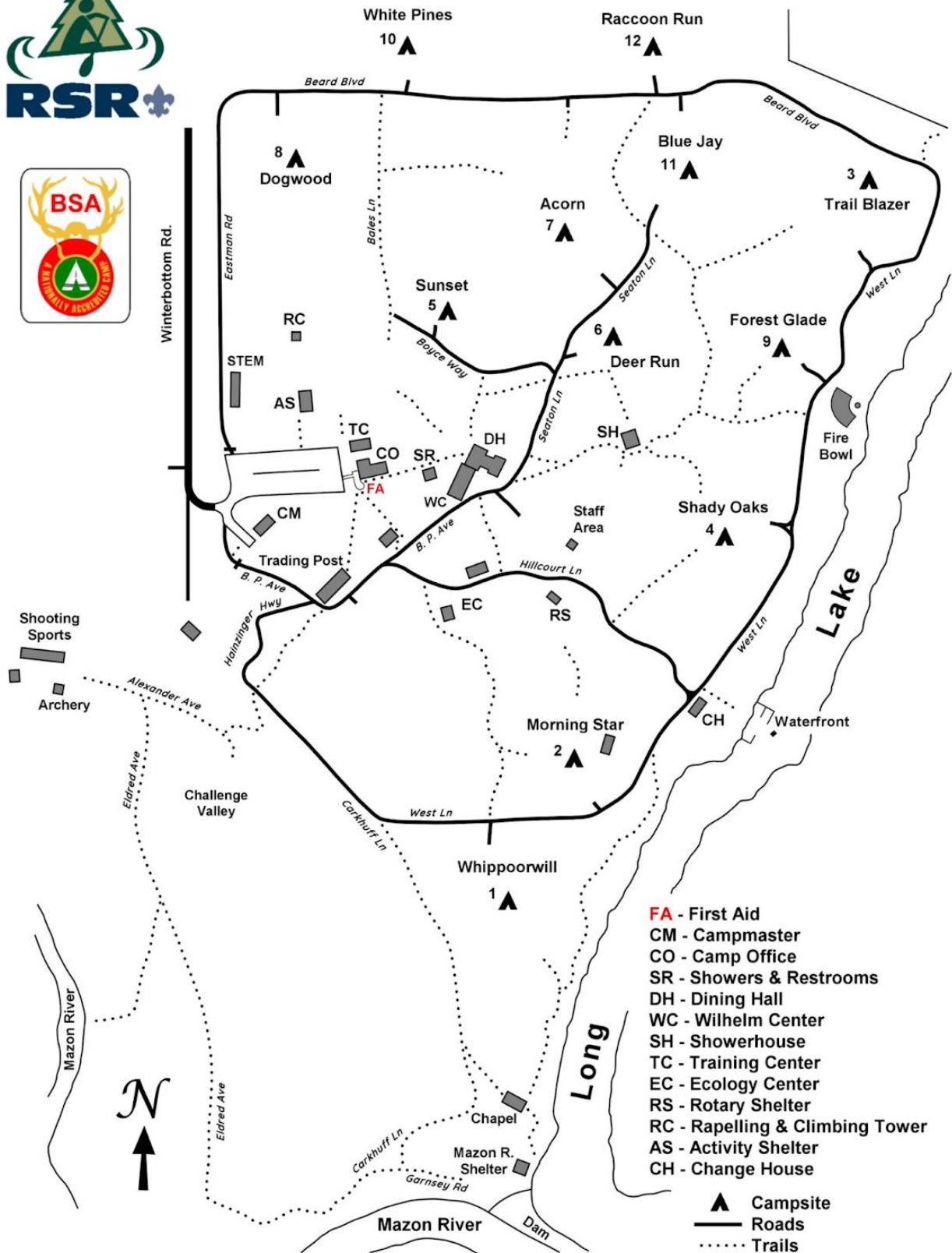
