

# Registration is open to Join Three Fires Council Jamboree Contingent

The 2026 National Jamboree will host approximately 20,000 Scouts BSA, Venturers, Sea Scouts, Explorers, unit leaders, JST (Staff), and visitors.

To attend the National Jamboree, a Scout must:

Be a currently registered member of Scouting America in a Scouts BSA troop, Venturing Crew or Sea Scout Ship:

- If attending as a member of Scouts BSA, a Scout must be at least 12 years of age and under 18 years of age at the time of Jamboree
- If attending as a member of a Venturing Crew or Sea Scout Ship, a Scout must be at least 13 years old and have completed the eighth grade or is age 14 and not yet 21 years of age at the time of the Jamboree

The only way for youth to attend the National Jamboree is through a council-sponsored contingent Scout BSA Troop or Venturing/Ship Crew. Attendance will be on a first come, first served basis, determined by when you sign up and paid the deposit to Three Fires Council.

# Additional Information

Three Fires Council is planning to send 3 Scout BSA Troops for boys, 1 Scout BSA Troop for Girls, and 1 Venture Crew/Ship to the 2026 National Scout Jamboree. Each Unit consists of at least 36 youth and 4 adult volunteers.

The 2026 National Jamboree takes place at Summit Bechtel Reserve in West Virginia July 22 - July 31, 2026. Our Council Contingent will depart early morning of July 21 to begin our journey to Jamboree and will return in the evening on July 31.

Scouts, Venturers or Shipmates must have a current Troop, Crew, or Ship membership. Scouts must be 12-17 years old. Venturers and Sea Scouts must be 14-20 years old.

**\*\*\* Special note for Scouts BSA Girls, Sea Scouts & Venturers\*\*\*** We are currently committed to 18 youth for our Scouts BSA Troop for Girls and our Crew / Ship. This means - the first 18 Scouts BSA girls to register are guaranteed a place in our Contingent. The first 18 Sea Scouts / Venturers that register are guaranteed a place in our contingent. After we fill the first 18 places, we will build our waitlist. Once our waitlist gets to 18, ALL 18 of those registered will be moved into the Contingent Troop/Ship/Crew.

The Jamboree will be estimated to cost \$2,495 spots are first come first served so register now.

The current Jamboree Fee Payment Schedule is as follows. You can always pay in advance if possible.

Deposit - \$375 – nonrefundable upon registering with Three Fires Council

Payment - \$1081.67 – March 15th 2025 (Includes \$375 Deposit & first payment of \$706.67)

Payment - \$706.67 – November 15th 2025 (Total expected payments to date, \$1,788.34)

Final Payment - \$706.67 – February 15th 2026 (Total paid to date, \$2,495)

NOTE: Payments are based on what TFC needs to pay to Scouting America for the event, so timely payments are necessary for attending.

Registering for the 2026 National Scout Jamboree is a one-step process. You register with the Three Fires Council to pay your Jamboree fees.
