

CAMP BELZER AND SKIP + ALEX LANGE INNOVATION CENTER
PARTICIPATION AGREEMENT, RELEASE AND ACKNOWLEDGEMENT OF RISK

In consideration of being allowed to participate, I acknowledge and agree for myself and on behalf dependent minors, as follows:

Climbing on artificial climbing walls, and related activities (including, but not limited to, bouldering, challenge type activities and fitness or exercise classes) exposes participants to numerous risks which might result in injury, death or property loss or damage. These risks include, but are not limited to, the following: falling, to the floor or pads; falling or swinging into the climbing wall and other structures and objects; being struck by falling climbers, hardware, tools, broken or dropped holds and other objects; entanglement in ropes; abrasions and/other injuries from contact with climbing walls or structures, ropes, holds, loose holds, dropped holds, broken holds, pads, or the floor. Climbing and belaying equipment and structures may malfunction, be defective, or fail; and absorbing materials, including pads, below the wall may not prevent all injuries from falls. Participants may participate out of control or beyond their limits or otherwise act in a negligent or intentional manner which contributes to the injury or death of themselves or another participant. Staff, visitors, belayers and other persons present may act negligently or engage in other wrongful conduct.

I acknowledge for myself and on behalf of the dependent child(ren), that I understand and assume any and all risks of participation in activities at Camp Belzer and the Lange Innovation Center activities and the use of its facilities and equipment, inherent or not, and whether or not described in this document.

I hereby release and covenant not to sue the Crossroads of America Council, Inc, its owners, successors, affiliates, employees and agents (hereinafter each a "Released Party", or collectively "Released Parties"), with respect to liability for any personal injury to myself or my dependent minor participant, including death, property loss or damage, and all other claims, demands or causes of action which accrue to me, which are in any way related to my enrollment or participation in an activity of Camp Belzer and the Lange Innovation Center. or the use of its facilities or equipment. These agreements of release and indemnity include claims of negligence (including, to the extent allowed by law, grossly negligent) acts or omissions of a Released Party, but not intentionally wrongful conduct.

I understand that photographs and video recordings which include me, or my dependent child(ren) may be taken at Camp Belzer and Lange Innovation Center facilities. I agree that the Crossroads of America Council, Inc. may use my or the child's likeness in all its publications and advertisements without payment or any other consideration.
