Good Afternoon,

I hope you are doing well and having a good week. All registered units have an important deadline coming up:

\$50 per Scout deposits due Monday, February 15 by 11:59 pm EST

Please note, the council office will be closed on February 15 in observance of President's Day. Payments can still be made online.

You will be responsible for paying \$50 for all Scout attendee spots on your reservation, regardless if they are named or not at this point. It is important to adjust your attendee count to the number of Scouts that have truly committed to camp thus far. Remember, you can always add more participants at any time.

- **If you need attendees removed from your reservation, please email me right away so I can adjust your counts prior to you making the \$50 deposits.**
- Crossover Webelos participants do not need to pay the \$50 deposit. However, if you know a Webelo is coming to camp and can enter their name now, then they should really be listed under the youth participant type. Changing a crossover to a youth participant is a change that I will need to do for you.
- Leaders do not need to pay the \$50 deposit

ACTIVITY SCHEDULE

The 2021 activity schedule will be released on March 1, and sign ups will begin in early April (exact date coming soon.)

COVID REFUND POLICY

- Should state officials ask us to reduce or not host larger gatherings, including summer camp, we will refund affected participants in full.
- Should a participant become ill prior to camp or other event, we will provide a full refund for the participant and any participating family members. The participant and participating family members will not be allowed to attend.
- We want to help you plan and minimize your risk. Should a person register for summer camp or a council event and later elect not to attend because of COVID-19 related concerns we will provide a full credit for future use.
