

Attention All Leaders:

Youth Protection Training Required for All Leaders!

The Boy Scouts of America requires Youth Protection Training for all registered adult leaders in all BSA programs. This training is required to be renewed every two years. All other adults and parents participating in Scouting are also strongly encouraged to take this online training.

TAKING THE TRAINING IN-PERSON AND ONLINE

To take the training online, visit www.my.Scouting.org and login if you are an existing member, or create a new account if you are new and about to register with the BSA. Once on www.my.Scouting.org, click on the Youth Protection icon, add the Mandatory Training to your learning plan, click on the My Learning tab and select the training from your plan. Once the training is complete, existing member's training records will automatically be updated with the certification.

All adults new to Scouting wishing to register must print their certificate and submit it with their application to the council service center. The training certificate will be sent to you via email, and it is also available to print after completing the three required training modules and passing the test. The training certificate may take up to 24 hours to appear in your record. It will be found by logging back on to www.my.Scouting.org and selecting the menu button in the upper left corner and clicking on My Dashboard.

From time to time, in-person training opportunities are offered. When available, information on the date, time and location of in-person Youth Protection Training can be found on our website in the training calendar at: http://www.northernstarbsa.org/For-Members/Training. Click on find a training course and then select Youth Protection from the Leader Specific Training drop down menu.
