I am providing this Release to Camp Arrowhead and the Ozark Trails Council, Scouting America and its affiliates, Oaks and Ivy Farm and Stables, LLC (each a "Releasee" and collectively, the "Releasees"), as a condition for allowing me, and the persons identified below, to enter the Ranch's premises and surrounding land, to be near horses, participate in equine-assisted activities, ride the horses, work near the horses, handle horses, use equipment, work with staff and volunteers, and/or receive instruction or guidance in riding, grooming, or handling the horses (the "Activities").

I/we are aware of and acknowledge the inherent dangers, hazards and risks associated with the Activities. I/we understand the inherent risks of the Activities mean those dangerous conditions which are an integral part of the Activities, include but not limited to:

1. The propensity of any equine to behave in ways resulting in injury, harm or even death to persons on or around them and/or damage to property in their vicinity.
2. The unpredictability of an equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons, or other animals.
3. The equine's response to certain hazards such as surface and sub-surface objects.
4. Collisions with other equines, animals, people, and objects.

The potential of any participant to act in a negligent manner may contribute to injury to the participant or others, such as failing to maintain control over the equine or to act within his/her ability. I/we assume these risks and accept the consequences involved in the participation of the participant registered on this form. I/we will consult with Camp Arrowhead's Program or Camping Director (or the staff of Oaks and Ivy Farm and Stables, LLC, as applicable) for advice in circumstances where safe practices are in doubt.

I/we do, to the fullest extent permitted under the law, hereby release and forever discharge each Releasee, and each Releasee's respective agents, and employees from any and all claims and demands of every kind, nature, and character which I or my minor child(ren) for any and all personal or property damages, losses, and injuries, which may be suffered or sustained while participating in any of the Activities or other activity connected with or ancillary to the Activities. I further covenant on my personal behalf and on behalf of my minor child(ren), my heirs, estate, assigns, and personal representatives, and assigns not to sue or otherwise make any such claims or demands. I further agree to indemnify and hold harmless each Releasee and each Releasee's respective affiliates, agents, and employees from any such losses or claims, including reasonable attorney's fees and expenses.

I/we have read and fully understand the content of this release of liability and agree to comply with the intent to hold harmless and/or to indemnify each Releasee, and each Releasee's respective staff, volunteers, or any other individuals and/or organizations involved, from any liability or injury resulting from participation in the Activities.

I/we understand it is always recommended I/we seek the advice of a physician, as many of the Activities pose special physical risks to the participant and even to the volunteer. I/we acknowledge it is my/our responsibility to make a Releasee aware of any conditions affecting my ability to handle, ride and /or be near an equine.
