Use this form to submit your unit bank account information to be used in transferring funds to and from Mid-America Council via ACH. The account used must be a unit checking account. The committee chair and one other registered unit leader must sign this form authorizing deposits and withdraws. **Deposits and withdraws will only be completed upon authorization from the unit for the amounts specified by the unit. This process simply allows Mid-America Council to keep your account information on file for those times; thus saving the unit leaders from having to provide this information each time.** All withdrawals from unit bank accounts will deposit into the Unit Deposit Account (UDA) at the Scout Center/Shop. That system will generate automated receipts to unit leadership listed on the UDA. All deposits to unit bank accounts will generate a remittance e-mail. If the unit has a generic e-mail address, please provide that below. Otherwise, the remittance will go to those listed on the UDA.
