I UNDERSTAND I AM NOT A LAW ENFORCEMENT OFFICER AND HAVE NO POWERS OF ARREST.

I UNDERSTAND THAT WHILE PARTICIPATING IN ALL ACTIVITIES WITH LAW ENFORCEMENT EXPLORER POST #592 SPONSORED BY THE DOUGLAS COUNTY SHERIFFS OFFICE I AM REQUIRED TO OBEY THE FOLLOWING RULES:

1. I WILL TURN MY CELL PHONE OFF OR ON VIBRATE WHILE PARTICIPATING IN THE ACTIVITIES. TEXTING IS PROHIBITED!
2. I WILL NOT CAUSE ANY DISRUPTION DURING THE ACTIVITIES. EXAMPLES ARE TALKING OUT OF TURN OR CARRYING ON PRIVATE CONVERSATIONS.
3. I WILL NOT USE ANY PROFANITY DURING THE ACTIVITIES. EXCEPTIONS ARE REPEATING CONVERSATIONS OR ACTS APPROPRIATE TO THE DISCUSSION.
4. I WILL NOT USE ANY TABACCO PRODUCTS DURING ACTIVITIES. INCLUDES THOSE OVER 18.
5. I WILL MAINTAIN A POSITIVE AND PROFESSIONAL APPEARANCE AT ACTIVITIES. PANTS WILL BE PULLED UP TO WASTE, SHIRTS WILL BE TUCKED IN, AND HATS ARE NOT WORN INDOORS.
6. I MUST MAINTAIN A GRADE POINT AVERAGE OF A "C" OR A "3".
7. I CANNOT BE ARRESTED FOR ANY CRIMINAL ACTIVITY (FELONY OR MISDEMEANOR).

I UNDERSTAND REPEAT VIOLATIONS (TOLD TWICE) OF RULES 1 THROUGH 5 WILL RESULT IN MY BEING ASKED TO LEAVE THE ACTIVITY AND NOT ALLOWED TO RETURN THAT DATE.

I UNDERSTAND THAT GRADES BELOW A C/3 WILL RESULT IN MY SUSPENSION FROM MEETINGS UNTIL I BRING MY GRADES UP.

I UNDERSTAND ANY ARREST WILL RESULT IN MY IMMEDIATE TERMINATION FROM THE PROGRAM.
