

National Youth Leadership Training



National Youth Leadership Training (NYLT) is an exciting, action-packed program designed to equip youth with practical leadership skills and experiences they can immediately apply within their unit. This two-weekend course emphasizes hands-on learning in a fun and engaging environment, combining activities, presentations, challenges, discussions, and games to reinforce key leadership concepts. Throughout the experience, participants build confidence, strengthen their ability to lead, and develop teamwork skills while working collaboratively with their peers. Every good troop, crew or ship sends at least one youth to NYLT per year!

Course Requirements: Candidates must be at least 13 years old and not yet 21 years of age, be a registered member of Scouting America, have achieved the rank of First Class, have completed Introduction to Leadership Skills for Troops (ILST), and have the recommendation of their Scoutmaster, Venturing Advisor, or Sea Scout Skipper. Participants are required to attend both weekends in order to successfully complete the course.
