**2026 ADULT ONLY TEAM WAVIER OF
LIABILITY & HOLD HARMLESS AGREEMENT**

{One Statement per Team with 1 to 5 Shooters. Parent/Youth form required separately for youth 14 to 17 year of age.}

As in all clay target shooting sports, there is the possibility of fragment deflection off trees, targets, and other solid objects on the shooting course. Likewise, pieces of clay targets (and even whole targets) may fall near or even strike the shooter. For all these reasons, the use of protective shooting glasses and ear protection is required.

1. I/We understand the inherent risks involved in recreational sport shooting, and by my/our signature/s, hereby **RELEASE, WAIVE, DISCHARGE, and HOLD HARMLESS** the Great Falls Council and the East Aurora Fish and Game Club, its employees, officers, volunteers and their immediate families from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by, or to any property belonging to me/us, while participating in the Great Falls Council Skeet and Trap Tournament, held on the property of the East Aurora Fish and Game Club, property located at 1018 Luther Rd, East Aurora, NY 14052.
2. I/We are fully aware of the risks and hazards connected with participating in this event, including the risk of physical injury, disability, or death. I/We are voluntarily participating in said activity and am entering onto the above-named premises to engage in such activity. **I/WE VOLUNTARILY ASSUME FULL REPSONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE, PERSONAL INJURY OR DEATH** that may be sustained, or any loss or damage to property, because of engaging in this event.
3. I/We further **AGREE TO INDEMNIFY AND HOLD HARMLESS** the Great Falls Council and East Aurora Field & Stream Club from any loss, liability, damage, or costs incurred due to participation and will be responsible for any medical costs associated with any injury arising from participating in the event.
4. It is my/our express intent that this Release and Hold Harmless Agreement shall bind the members of family members, spouse (if any), and heirs, assignees and personal representatives, and shall be deemed as a **RELEASE, WAIVER, AND DISCHARGE** of the Great Falls Council and East Aurora Field & Stream Club. I/We hereby agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of New York.
5. I/We further agree to become familiar with the rules and regulations (verbal or written) of this event. I/We will further assume complete risk of any activity done in violation of any rule, directive, or instruction.
