Some of these merit badges have a set of requirements that may require the scout to work on them outside of the week-long time they have to explore them at camp. While these requirements are stated as a pre-requisite for the merit badge, I'd like to invite you to think about these as post-requisites as well. Do not feel stressed if your scout does not complete these requirements before camp begins. We must always remember that at summer camp, fun and adventure come first. Camp can be a great way to spark an interest in a new subject for a scout to be explored afterwards as well. In this guide, you will find the pre-requisite requirements for all scheduled and open program merit badges offered at Massawepie for 2024 as well as some special considerations to note about specific merit badges/programs.
