a minor, do hereby give my child express permission and consent to be furnished and be in possession of a firearm(s) and ammunition provided by the Longhouse Council of Scouting America or by authorized staff or members of the Longhouse Council, for the purpose of allowing my child to engage in lawful, recreational sporting activities, including participation in instruction in the safe handling and shooting of firearms, target shooting, shotgun shooting, or in related firearms activities conducted under the supervision of current National Rifle Association Certified and Longhouse Council approved Range and Target Activities Instructors or under the supervision of NRA-certified Instructors and SA Rangemaster staff retained by the Longhouse Council of Scouting America in compliance with all applicable New York State Laws.

I understand that for the purposes of this consent, "firearms" includes any handguns, or long guns that may lawfully be possessed by a minor under state and federal law, based on the age-appropriate programs in the Scouting America Range and Target Activities Manual and the Guide to Safe Scouting.

I also give my child express permission and consent to be furnished with and to utilize SA approved archery equipment, slingshots, catapults, bottle rockets and ammo, based on the age-appropriate programs in the BSA Shooting Sports Manual and Guide to Safe Scouting.

This form must be signed for all minor scouts, even if their parent or legal guardian is on the range with the scout.

I understand that I may revoke this consent at any time by notifying the Golden Empire Council in writing. This consent will only apply to firearms, ammunition, BB devices, archery equipment, sling shots, and catapults, furnished to or possessed by my child during any APPROVED SA Longhouse Council or District event where these devices are used as part of a program provided by the Longhouse Council or its subsidiary districts, and will not be valid for any other firearms related activity conducted during any other time-period. A photocopy or facsimile of this written consent will serve as an original. This written consent form will be in the possession at-all-times of the Longhouse Council staff /instructors supervising the event for safekeeping. **This form must be completed for each scheduled event.**
