THE H. KARL BUTLER LEGACY OF SERVICE AWARD NOMINATION FORM

The H. Karl Butler Legacy of Service Award is a distinguished Council-level recognition presented to a Scouter whose lifetime of service, generosity, and commitment has had a profound and enduring impact on the Council and the young people it serves.

Named in honor of H. Karl Butler, whose vision and generosity helped secure Scouting's future for generations, this award recognizes individuals who exemplify selfless service, steadfast leadership, and a deep belief in the mission of Scouting.

Like its namesake, recipients are those whose contributions extend beyond a single role or moment and whose influence continues to shape the life, culture, and the strength of the Council over time.

This award is intended to honor Scouters who have demonstrated:

- Exceptional and sustained service to the Council for at least twenty years.
- Extraordinary generosity of time, talent, and/or resources in support of Scouting's mission.
- A legacy-minded commitment, ensuring that Scouting remains strong and accessible for future generations.
- Leadership with integrity, marked by reliability and an exceptional devotion to service rather than recognition.

Recipients of the H. Karl Butler Legacy of Service Award are individuals whose lives reflect Scouting's highest ideals and whose contributions have become part of the Council's living heritage. Their service leaves an imprint on camps, programs, people, and possibilities, echoing long after their work is done.

This award is presented at the discretion of the Council to one Scouter per year whose record of service truly embodies the legacy worthy of the name H. Karl Butler Selection Committee.
