

Top Shot Events:

Rifle - Scouts will shoot at targets on the rifle range. Scouts must be 14 years or older to participate in this event.

Archery - Scouts will practice shooting at targets at the archery range.

Tomahawk Throwing - Scouts will test their accuracy with tomahawk throwing.

Spatula Throwing - We're bringing back a fan favorite from our last Klondike. Scouts will practice their tomahawk skills with our spatula throwing contest.

BB - Scouts will practice their shooting skills with BB guns. All scouts may participate in this event.

Water Balloon Slingshot on the High COPE - Practice your slingshot skills by attempting to shoot water balloons through tires on the high COPE course!

Frisbee Golf - Scouts will be shooting for the lowest score on our frisbee golf course to earn points for their patrol.

Trebuchet Building - The goal here is to build a trebuchet from nearby materials. Points given for functionality.

Basketball - Practice your shooting skills in a basketball game with your patrol.

Battleship - Test your patrol team-skills in this life-sized game of Battleship.

Sizzler - We're opening up the sizzler while the weather is still nice enough for the year!

Climbing Tower - We're opening up the climbing tower while the weather is still nice enough for the year!

Volunteer Opportunities- WE NEED YOU! We are looking for troops to run stations for Top Shot. If you are interested in running a station, email Kim at kwheatley2018@gmail.com with your station of interest. All materials will be at the assigned locations for the event. You must notify Anthony at anthony.dworning@scouting.org if program supplies need to be purchased. Station Mayors will need to check in Saturday morning at the Welcome Shelter before reporting to the station. As the Mayor of the station, you are expected to be at the station from 8:00am-12:20, and then from 1:45 to 6:00. Please contact Kim Wheatley ASAP to sign up for your stations.

For Up-To-Date information, please sign up for Text alerts- text “@topshotc” to 81010. This will allow the camp staff to contact units prior to camp and while at camp about changes to the schedule, incumbent weather, trading post hours, and other information.

Event COVID Procedures:

1. State guidelines for camping only allow for two types of camping. Family camping where groups of no more than ten can stay together at a campground. Groups who are family camping must be from the same household. The state also allows for health department licensed resident camps to operate with cohort groups of no more than ten people including adult leadership.
2. Weekend camping at Lake Erie Council camps operates under our health department-issued residential camp license. There will be a certified National Camp School trained Camp Director on the property providing leadership for following the operations plan. There will also be a Lake Erie Council approved health officer who will be responsible for entrance temperature checks and ensuring that pre-screening and temperature checks have been completed.
3. Patrols are limited to 10 people including adult leaders. Hence, the troop will need to split into patrols/groups before attending. Patrols must have separation and, should operate together, but not mix with other patrols. While the Troop may bring multiple patrols to a campsite, these patrols need to operate independently of each other.
4. Masks are required inside buildings per state orders. Masks must also be worn outside when social distancing of at least 6 feet from non-household members cannot be maintained. Exceptions for masks are designated by the state order.
5. Camping is permitted for Scouts living in counties at alert levels 1, 2, or 3. If your unit's county is above level 3, you are prohibited to camp at a Lake Erie Council camp. If Ashtabula County is at a level 4 alert level, Beaumont will be closed for the duration of the time at alert level 4, and the event will be postponed.
6. Everyone arriving at camp must bring a current copy of the [Temperature and Prescreening Questionnaire](#). This form must be filled out completely. This form must be signed by the unit leader prior to departure to camp. Forms will be collected at check-in and will be kept by Lake Erie Council.
7. Each unit must submit [a roster of participants](#) attending camp divided by respective patrols/dens. This roster must include address, phone number, and email for each participant or participant parent in case Lake Erie Council needs to contact individuals about an exposure.
8. Upon arrival at camp, temperatures will be checked of everyone arriving at camp. Health forms will also be reviewed by the health officer staff. Participants must remain in their vehicle until screened by health officer staff. Friday night check-in will have scheduled arrival times, sent to you via email by Thursday, 9/17.
 - a. Beaumont Scout Reservation: Check-in will take place in the Camp Gray parking lot. Temperatures will be checked and symptoms screened while participants are still in their vehicles. After temperatures are checked and

confirmed under 100° F, campers will be allowed to exit their vehicles to wash their hands at the Camp Gray Activity Center.

9. If the screening, temperature logs, or temperature check indicates that a person within the vehicle could have symptoms of COVID-19, the entire vehicle may be denied entrance to camp by the health officer staff.

10. If any individual Scout, leader, or parent knows they have been in contact with a person who has tested positive of COVID within the last 14 days, the individual must disclose this information and will not be permitted onto camp. They will be asked to leave property if they find out they have been in contact with a positive COVID person while at camp.

11. **Daily Temperature Checks:** The unit leadership will be responsible for submitting temperatures of every participant at camp before noon each day. This means that if a unit is staying Friday – Sunday, they will need to submit temperature checks of the entire unit participating in the morning on Saturday and Sunday.

12. **Camping/Lodge Configuration:**

a. Campsites will accommodate multiple families, patrols, and/or dens. Units must separate tents into family, patrol, or den mini sites in the campsite. In Cub Scouts, families can share a tent. In Scouts BSA, each participant must use their own tent. The exception to this is if there are two members of a patrol who live in the same household at home.

b. Lodges will have a maximum capacity of 10 participants per room. This includes unit leadership. Beaumont Lodges have been configured to sleep a maximum of 24 people.

13. **Sanitizing:** Each group will be provided with a bottle of sanitizer spray that must be used three times per day on common surfaces. In a Lodge/Cabin this includes picnic tables, doorknobs, latrines/porta potties, kitchen equipment, and sinks. In a campsite this includes picnic tables, latrines/porta potties, and hand-washing stations.

14. **Hand-washing:** Hand-washing is mandatory before and after meals, as well as before and after participating in activities. In cases where handwashing is not possible, the camp will provide hand sanitizer.

15. **Restrooms:** On weekends when events take place, common restroom facilities will be open and cleaned three times per day.

A Scout is Trustworthy and a Scout is Clean. Failure to follow any of these guidelines can result in your unit's dismissal from camp.

General Rules and Info for Event:

- Trash from campsites must be disposed of at the dumpster in the parking lots. Thanks!
- Drink plenty of water!

Medical Forms & Health Officer: As stated in the Guide to Safe Scouting, leaders should have the Annual Health and Medical Form for each unit member participating in the event. These are especially important to have if a Scout will be attending event without a parent. The form can be downloaded from the Lake Erie Council website. The Health Office is located next to the Augustus Training Center; the health officer will be on staff 24 hours a day throughout the weekend.

Sign in/Check in: Please see bullet #8 in the "COVID Procedures" Section of this Guide.

Adult Participation: In order to comply with Youth Protection "Two Deep" guidelines, all members of your troop must have Youth Protection. One of the adults must be a registered BSA leader.

Alcoholic Beverages and Drugs: Possession and/or use of alcoholic beverages or drugs are prohibited. You will be asked to leave the Klondike if found with either and may be prosecuted.

Parking, Driving & Trailers in Camp: Please take only 1 vehicle per unit to your campsite. Try to stay on the road to avoid getting stuck.

Emergency Drill: In order to ensure preparedness of all attendees for potential crisis situations, there will be an emergency drill during the first 18 hours of camp. When the alarm is sounded, please gather at your campsite, confirm all troop members are present, then send one representative to each reception center in either McIntosh, Broadbent or McCahill.

Check-Out: Schedule a time with Jake, Anthony, Colleen, or Kim (via text or remind). That is the time you should be fully packed up, campsite patrolled. One of the event staff will arrive to inspect your campsite. Once your site is inspected, you will receive your patches. Once you receive your patches, you will be cleared to leave camp.
