The following is a summary of the questions and answers presented through the chat during the meeting.

Question: Please enter your name and Scout unit for attendance purposes.

Question: Re: Resident Camp (Cub Scouts - Bear rank), is a parent required to attend?

Response: There must be two registered adult leaders from the unit present at camp.

Question: How do we know if two leaders from our unit are registered already? As a parent, I was not planning to accompany my child. And is the unit the den or the pack?

*Response:* When units register for camp, the primary leaders are identified. The unit is the pack. The pack will be together in a campsite.

Question: Clarification on adults at resident camp - Do all adults staying need to be registered? I have at least one parent who may want to be there to experience camp with his child, but he will not be a leader. Does he need to be a registered member in Scouting America?

Response: They do not need to be registered as long as they are not providing any supervision to a child other than their own. However, the unit must still meet the two deep leadership requirement with registered leaders.

Question: Do Cub Scouts need to sign up for specific activities? As a parent, I don't think I've seen communication about that...

Response: No, Cub Scout camps are set up differently and they travel to program areas as a group.

Question: Do Scouts with dietary needs need to fill out the Special Diet Form for Cub Scout Day Camp Grab and Go lunches?

Response: Yes, please make sure that anyone participating in Cub Day Camp with special dietary needs completes a form. That includes parents as well.

Question: Love the change to the Day Camp lunch - thank you!!

Response: You are welcome. We would love post camp feedback on how it goes.

*Question:* Just to confirm - friends coming to Day Camp need to be registered with Scouting *America*?

Response: Correct

Question: For the cub scout resident camp (first time webelo), do I we need the doctor signoff on the medical form?

Response: Due to the length of camp, all 3 parts of the medical form A/B/C need completed. That includes the physician signature on part C.

### Question: If a child has medications, how are those checked in and administered?

Response: The medication can be administered by the parent or unit leader. Inhaler and EpiPens can be kept by the Scout or leader. Medications that require refrigeration can be kept in the Health Lodge.

Question: Who do I send the medical form to? (email address) Or do I upload it to the registration website? thks

Response: Health forms can be brought to Cub Day camp check-in. Resident camp participating units need to drop off or mail the unit's med forms to the council service center or camp.
