We agree to defend and indemnify the Released Parties from and against any and all claims, actions, proceedings, damages, liabilities, and expenses of every kind that in any way relate to, result from, or arise out of the Participant participating in the target and range sports program.

I understand that any additional cost associated with participation in these programs will not be refunded if my child is removed for behavioral problems. For safety, my child and I agree that they will do the following or they will be removed from the program:

1. Complete a range safety briefing.
2. Wear required safety gear while on the range.
3. Follow all the safety provided in the safety briefing.
4. Follow the instructions of the Range Safety Officer(s), NRA Rifle Instructor, NRA CO-OP Muzzeloading Rifle Instructor, NRA Shotgun Instructor, NRA Pistol Instructor, Scouting America Archery Rangemaster, Scouting America BB Gun Rangemaster, Scouting America Tomahawk Range Safety Officer, Scouting America Knife Throwing Range Safety Officer, and/or those with superseding training.
5. Do not handle the bow or firearms until instructed to do so by the qualified instructor(s) listed above.
6. Is registered as Scouting America, Sea Scout, and Venturer.

Archery

Scouting America offers instructional and open shoot static archery programs. In these programs, Scouts will handle nocking arrows, drawing the bow, and releasing to shoot at a static target under the supervision of a Scouting America Archery Rangemaster.

Rifle Shooting

Scouting America offers instruction and open shoot rifle programs. In these programs, Scouts will handle a .22 rifle, load the rounds, and shoot at static and/or moving targets under the supervision of an NRA Rifle Instructor.

Shotgun Shooting

Scouting America offers instructional and open shoot shotgun programs. In these programs, Scouts will handle 12-gauge or 20-gauge and shoot at moving clay targets under the supervision of an NRA Shotgun Instructor

Cowboy Action Shooting

Scouting America offers a Cowboy Action Shooting program. Scouts will shoot a rifle, pistol, and shotgun under the supervision of an NRA Rifle Instructor, NRA Pistol Instructor and NRA Shotgun Instructor. Participants must be 14 years of age, or 13 years of age and completed the eighth grade, at the start of the activity and will be in full compliance with all local, state, and federal guidelines, including age restrictions and original equipment manufacturer standards.

I, the undersigned, verify that my child is 14 years of age, or 13 years of age having completed the eighth grade, and has my permission to participate in Cowboy Action Shooting. **Initial** _____

Tomahawk Throwing

Scouting America offers a tomahawk program. In this program, Scouts will handle specially-designed throwing tomahawks and throw at static targets under the supervision of a Range Safety Officer.
