# Eagle's Challenge Official Rules

#### Overview

The Eagle's Challenge is a special side competition held in conjunction with the Sporting Clays Classic. Participants who successfully break all 100 clays (a perfect score) during the challenge will be eligible to win a high-value firearm prize.

This is a separate event and requires a distinct entry fee and signed acknowledgement of the competition rules. Performance in this challenge does not affect scoring in the main event.

#### 1. Eligibility

- Open to all registered shooters of the Sporting Clays Classic.
- Participants must be legally permitted to possess firearms.
- Must be 18 years or older or accompanied by a parent/guardian if underage per local laws.

## 2. Entry Fee

- The Eagle's Challenge requires a separate entry fee of \$100.
- Entry must be completed and paid prior to shooting your registered Sporting Clays round.
- Only one entry per shooter.

# **3. Competition Rules**

- The competition is run concurrently with the shooter's main 100-target Sporting Clays round.
- To qualify, a participant must break all 100 targets with no misses.
- Targets must be shot in the presence of certified referees or designated scorers.
- No practice targets or re-shoots are allowed within the challenge.
- Shooters must adhere to all rules and safety protocols of the event.

## 4. Prize

- The shooter who completes the Eagle's Challenge with a perfect score will win the designated high-value firearm (details announced at the event).
- If multiple shooters break 100, a shoot-off will determine the winner (see below).
- If no shooters break 100, there will be no prize!

## 5. Tie-Breaking / Shoot-Off Procedure

If two or more participants complete a perfect round:

- A sudden-death shoot-off will be held on a designated station.
- Shooters will shoot identical presentations, one at a time, under referee supervision.
- Each shooter will shoot pairs (report or true, as designated).
- The shoot-off continues until one shooter emerges as the last to hit both targets while others miss.
- The order of shooting will be determined by random draw.
- The winner of the shoot-off will be awarded the firearm prize.

## 6. Firearm Prize Transfer

- Winner must complete all legal paperwork and background checks as required by federal and local law.
- Winner is responsible for all transfer fees.
- If winner is ineligible to receive a firearm, the prize may be forfeited.
- No cash alternative will be offered.

# 7. General Conditions

- The event organizers reserve the right to interpret, amend, or modify these rules at their discretion.
- All decisions made by referees and event staff are final.
- Unsportsmanlike conduct may result in disqualification without refund.
