I approve the attendance of my son/daughter named above at the National Youth Leader Training Conference as described above. I have discussed the importance of following all rules during the training course and understand that violating these rules could result in expulsion from the course. I understand that no refunds will be given if my child does not complete the course for any reason (except out of concern for COVID-19). I have reviewed all information provided on the various forms for accuracy and will provide all required documents as outlined in the NYLT Required Forms and Documents section of the Welcome Letter. I understand that face coverings will, if required, be properly worn at all times except during meals and when participants are in their tents.

The NYLT adult staff will handle any medical issue in accordance with Cradle of Liberty Council policies – from administering first aid through transport to a medical facility (via staff vehicle or emergency services) as needed. There will be an outpost hike within Musser Scout Reservation. Adult staff will be camping nearby to provide oversight. At no time will your son/daughter leave Reservation property except in the event of a medical emergency. **I understand that a Final Course Assessment will be provided to me, my child and his/her unit leader, and useful leadership information to reinforce these skills will be emailed to me and my child for up to two years following course completion. Further, I understand the policy regarding electronic devices:**

- 1) We will not allow phone calls to/from friends or parents during the course times. Phones should be turned off during all course presentations. Since cell phones have become a multi-use tool, they can be used as cameras or alarm clocks, as needed. As with typical school policies we expect each participant to make good choices as to the use of cell phones.
- 2) MP3 players may be used only in tents and only with earphones. If music can be heard outside the tent the MP3 player will be collected and returned at the end of the course. Note that the only time you'll be in your tent is at lights out until wake-up the next morning.
- 3) Electronic games should not be brought. There will be no time to use them.
- 4) Lost or stolen electronic devices are the individual's responsibility (except for cell phones turned over to staff)
