**** LIABILITY RELEASE and ASSUMPTION OF RISK ****

This waiver applies to using the facilities at the South Carolina Governor's School for Agriculture at John de la Howe, located on 192 Gettys Road McCormick, SC. Use of this property, you are informed that you and/or your group are assuming all risks associated with the participation of your planned activities. Such risks include loss or damage to personal property, injury, collision with an object, accidents, and other unforeseeable events.

I, the undersigned, hereby acknowledge that I fully understand that there are inherent risks involved in the use of the facilities at the South Carolina Governor's School for Agriculture at John de la Howe. I expressly state that I assume all risks for myself and any other persons associated with this project.

I understand said risks, and that I specifically release the South Carolina Governor's School for Agriculture at John de la Howe, its staff, its officials, and other agents from any liability as to any right of action or claim to relief that may accrue to me or my heirs or personal representatives for any such personal injury, loss of life, loss of consortium, or loss of or damage to property, including gross negligence or reckless misconduct, which I or anyone else in my party may suffer before, during and after all activities associated with the use of the property. The terms hereof shall serve as a release and expressed assumption of risk for my heirs, executors, administrators, myself, and all individuals accompanying me.

I further agree to be responsible for all equipment and vehicles brought on to the property of the South Carolina Governor's School for Agriculture at John de la Howe. I acknowledge that I am responsible for any and all damages that I or others in my group or under my employ may cause and will compensate the South Carolina Governor's School for Agriculture at John de la Howe fully for any destruction of property or other losses that I or my actions cause.

I understand that the use of alcoholic beverages and other drug use is strictly prohibited by all individuals in the party of use of the property.

I will comply with the requests of any South Carolina Governor's School for Agriculture at John de la Howe employee who believes that my use of the property does not meet the stipulations of this agreement and asks me to stop use of the facilities or curtail my activities until a resolution of such concerns can be determined by both parties.
