

Popcorn Sales Incentive FAQs

Congratulations on selling enough popcorn to earn your way toward a Circle Ten camp or training. Outlined below are important steps to ensure your incentive is applied to your selected event.

Where can I use my incentive?

NYLT 2021	\$100 will be applied toward your registration
Summer Camp 2021	\$100 will be applied toward your registration
Resident Camp 2021	\$100 will be applied toward your registration
Winter Camp 2021	Free registration (excludes late fees)
Cub Scout Day Camp 2021	Free registration (excludes late fees)

How do I have my incentive applied to my registration?

DAY CAMP:

If registering with a Pack:

- If a Pack is registering the Scout as part of a Unit reservation, please follow the steps for Summer Camp (below).
- The Scout will receive a full credit toward their registration fee. No other costs will be covered.

If registering individually:

- Begin your registration and continue the registration process until you reach checkout. Do not complete checkout. Close out of your registration. It will be saved as “in-progress”.
- **Important!** The Scout’s name and email address must match those listed on the Trail’s End account
- Email Paula Bramble at Paula.Bramble@scouting.org with the Scout name, email address, and name of event.
- The incentive will be credited to the reservation upon verification of the Scout’s name and email address.
- You will receive an email with the reservation confirmation once the credit has been applied.

NYLT

- Begin your registration for your preferred event and continue the registration process until you reach checkout. Do not complete checkout. Close out of your registration. It will be saved as “in-progress”.
- **Important!** The Scout’s name and email address must match those listed on the Trail’s End account
- Email Paula Bramble at Paula.Bramble@scouting.org with the Scout name, email address, and name of event.
- The incentive will be credited to the Scout’s reservation upon verification of the name and email address.
- You will receive an email with the reservation confirmation once the credit has been applied.

SUMMER, WINTER, & RESIDENT CAMP:

- The Unit should register the Scout as part of his/her group.
- **Important!** The Scout's name and email address must match those listed on the Trail's End account
- Email Paula.Bramble@scouting.org once the Scout is registered.
- \$100 credit will be applied toward the Scout's registration.
- The credit will only cover the registration fee.
- This credit is non-transferrable and is only for the Scout's reservation.

Important FAQs:

- The incentive can only be applied toward the registration fee. It cannot be applied toward any other fees such as late fees, merit badges, additional purchases such as patches, hats, t-shirts, etc.
- The incentive is solely for the use of the Scout. It cannot be transferred or split between other Scouts.
- Cancellations: Should a Scout cancel, the incentive will be returned to the Council. A Unit cannot keep the credit to be applied to another Scout. The Circle Ten Cancellation Policy will apply to any money paid out of pocket. There will be a cancellation fee for the amount paid by the registrant.
- This incentive may only be used one time and only for the events listed on this document.
