Section I. Arrival

Friday Check-in will occur between 6-7:45pm adjacent to the main parking lot.

Saturday Morning Check in will be from 7-8 am in the Main Parking Lot.

Things to Bring for Check-in:

Updated Roster if any alterations to online registration are needed Current and complete Medical Forms (Parts A and B) for everyone in camp. Parent Permission Forms for Cowboy Action participation for all scouts aged 14+ (or completed 8th grade and 13 years old.)

Medical Needs

Please ensure that all medical needs and conditions are listed in your online registration. This ensures we are aware and prepared to handle any potential challenges. If you have purchased lunch tickets, Dietary needs must also be updated in the online registration.

Parking, Unloading of Vehicles & Trailers

All vehicles will be parked in the main parking lot. Please back in your vehicle.

Unit campsites are for tent camping only – no RV's or pop-up campers of any kind are allowed.

Gear Load-in

One vehicle per unit at a time will be allowed to drive into camp to unload gear near your campsite. Please follow staff and posted instructions and directions and stay on roadways. Do not block the road while you are unloading. Even roadways can be soft this time of year: We really don't want to assist you in removing your vehicle!

Gear Load-Out

Again, one vehicle per unit at a time will be allowed to drive into camp. Please refrain from going to get your vehicle until your unit's gear is packed and ready to be loaded. Do not block roadways while loading.

If your unit is utilizing a trailer, please <u>let the Camp Director know ASAP</u> so that we can make the best campsite arrangements. Trailers will need to be unloaded and returned to the parking lot. Not every campsite is accessible by vehicles with a trailer.

Late Check-in (Friday Night)

If you will be arriving after 7:45pm on Friday, Please inform the Camp Director ASAP.

SECTION III. Program Activities

Mandatory Safety Briefing

Two Safety Briefing sessions will be offered. All scouts and any adults who wish to participate in afternoon open shoot MUST attend atleast one session.

8pm Friday Night: Held in the Grizzly Lodge.

8am Saturday Morning: Held in the Grizzly Lodge.

Morning Course of Fire

Each Scout will receive a Course of Fire card during the Mandatory Safety Briefing.

Course of Fire will include Shotgun, Rifle, Archery, Sporting Arrows, Tomahawks, Cowboy Action and Muzzleloading.

Scouts need not participate in all events however firearm events are limited to their course of fire in the morning.

Lunch Break

Those that purchased Lunch Tickets through their registration will receive their lunch ticket during check in. Proceed to the dining hall for Lunch. Must present Lunch Ticket!

Units may choose to cook their lunch in their campsite or if cooking is not required (such as for a trail style lunch), units may choose to sit in the dining hall, es Kai'elgu shelter or picnic on the parade field.

Afternoon Open Ranges

Ranges will be ready to open again at 1:30 pm for afternoon Open Shoot.

For Scouts, all ranges EXCEPT shotgun are open and free. Cowboy Action rounds in the afternoon will consist of revolver and rifle only. Shotgun tickets may be purchased in the trading post.

For Adults, Tomahawks, archery and sporting arrows are open and free to participate. All other ranges require tickets purchased from the Trading Post and are priced as follows:

- * .22 Rifle: \$1 for 10 shots
- * Cowboy Action: \$1.25 for 1 round (6 shots of .22LR and 6 shots of Revolver Pistol., no shotgun)
- Muzzleloading: \$1 for 2 shots
- * Shotgun: \$3 for 5 shots or \$15 for 25 shots

Scouts will be prioritized on ranges before Adults however unless a scout is working on a Marksmanship program or Merit Badge targets, they will be asked to rotate when other participants are waiting.

Trading Post

The trading post is stocked with snacks and Grizzly Gear!

If you pre-purchased a new Shooting Sports zip up hoodie, they will be available at the trading post Friday evening and Saturday.

All range tickets will be available in the trading post to purchase all day.

We are equipped to accept cards and cash in the trading post.

- Personal firearms and archery equipment
- Personal watercraft
- Tobacco products, including Vape pens
- Illegal drugs and alcohol
- Fireworks
- Chainsaws

SCOUT COWBOY ACTION SHOOTING PROGRAM

PARTICIPATION AND HOLD HARMLESS AGREEMENT

Inland Northwest Council will be conducting a Scout cowboy action shooting program. In this program, Scouts will shoot a rifle, pistol, and shotgun under the supervision of an NRA Range Safety Officer and NRA certified instructors. Scouts will be required to wear eye protection and hearing protection at all times while on the range. Scouts are expected to abide by all safety rules and the instructions of the Range Safety Officer(s) and rifle, pistol, and shotgun instructor(s).

I, the undersigned, give my child, _______, permission to participate in this program. I understand that participation in the activity involves a certain degree of risk. I have carefully considered the risk involved and have given consent for my child to participate in the activity. I understand that participation in the activity is entirely voluntary and requires participants to abide by the rules and standards of conduct. I release the Boy Scouts of America, the local council, the activity coordinators, and all employees, volunteers, related parties, or other organizations associated with the activity from any and all claims or liability arising out of this participation.

For safety, my child and I agree that he/she will do the following or he/ she will be removed from the program. I understand that any additional cost associated with participation in this program will not be refunded if my child is removed for not following the rules below.

- 1. Complete a range safety briefing.
- 2. Wear all safety gear at all times while on the range.
- 3. Follow all the safety rules provided in the briefing.
- 4. Follow the instructions of the Range Safety Officer(s) and rifle, pistol, and shotgun instructor(s).
- 5. Do not handle the firearms until instructed to do so by the instructor(s).
- 6. <u>Is 14 years of age, or 13 and has completed the eighth grade</u>, as of the start of the class and will be in full compliance with all local, state, and federal guidelines, including age restrictions and original equipment manufacturer standards.
