Section I. Arrival

Friday Check-in: Those who are camping will be assigned campsites by the Camp Ranger, Leo.

Staff will check on you in your site Friday evening.

Saturday Morning Check in will be from 7-8:15 am in Carbon Lodge.

Participants will receive an updated camp map and schedule at check-in.

Parking, Unloading of Vehicles & Trailers

On Friday, if roads are clear, you will be able to drive to your site as normal. If significant snow comes in the day or two before the event, you may need to be prepared to transport your gear from the Carbon Lodge Parking Lot to your site without your vehicle.

Saturday Event Parking: Park in the Carbon Lodge Parking Lot. Vehicles parked along an edge of the lot should be backed in.

Things to Bring for Check-in:

- Updated Roster if any alterations to online registration are needed
- Current and complete Medical Forms (Parts A and B) for everyone in camp.
- Parent Permission Forms for Cowboy Action participation for all scouts aged 14+ (or completed 8th grade and 13 years old.) (available on pg 6 and in online registration portal)

Medical Needs

Please ensure that all medical needs and conditions are listed in your online registration. This ensures we are aware and prepared to handle any potential challenges. If you have purchased lunch tickets, Dietary needs must also be updated in the online registration.

ALL participants must have Medical Form parts A & B with them upon arrival, per Scouting policy.

Use of Carbon Lodge

Carbon Lodge will be open and accessible throughout the weekend for restroom access, warming up and for eating of meals if so desired. Units are welcome to use one of the picnic tables outside the lodge for a kitchen area if planning to sit inside for a meal.

PARTICIPANTS ARE RESPONSIBLE FOR SUPPLYING OWN MEALS.

SECTION III. Program Activities

Mandatory Safety Briefing

One Safety Briefing session will be offered: 8:30am on Saturday. All scouts and any adults who wish to participate in afternoon open shoot <u>MUST</u> attend

8:30 am Saturday Morning: Held in Carbon Lodge.

Morning Course of Fire

Each Scout will receive a Course of Fire card during the Mandatory Safety Briefing.

Course of Fire will include Shotgun, Rifle, Cowboy Action and Muzzleloading.

Scouts need not participate in all range activities. Those who have not yet used all of their course of fire shots will get priority during open range time.

Lunch Break

Those that purchased Lunch Tickets through their registration will receive their lunch ticket during check in. Proceed to Carbon Lodge for Lunch. Must present Lunch Ticket!

Units may choose to cook their lunch in their campsite or if cooking is not required (such as for a trail style lunch), units may choose to sit in Carbon Lodge.

Afternoon Open Ranges

Ranges will be ready to open again from 1:15-4 pm for afternoon Open Shoot.

For Scouts, all ranges EXCEPT shotgun are open and free. Cowboy Action rounds in the afternoon will consist of revolver and rifle only. Shotgun tickets may be purchased in the trading post.

For Adults, all ranges require tickets purchased from the Trading Post and are priced as follows:

- * .22 Rifle: \$1 for 10 shots
- * Cowboy Action: \$1.25 for 1 round (6 shots of .22LR and 6 shots of Revolver Pistol., no shotgun)
- * Muzzleloading: \$1 for 2 shots
- Shotgun: \$6 for 5 shots or \$30 for 25 shots
 (Shotgun range requires steel shot: Price may be adjusted to cover market values)

Scouts will be prioritized on ranges before Adults however unless a scout is working on a Marksmanship program or Merit Badge targets, they will be asked to rotate when other participants are waiting.

If you purchase shooting tickets during this event and are unable to redeem them, please return to the trading post for a refund. They cannot be honored at future events.





SECTION IV. Other Notes

Final Updates

All participants will receive updated schedules, maps, etc at check-in. Ranges may be added or modified due to volunteer personnel, weather and light conditions day-of or as needed. These updates will be

communicated during the safety briefing or morning announcements at the opening flag ceremony.

Trading Post

Located in Carbon Lodge, the trading post will be stocked with snacks and Scouting Gear!

All range tickets will be available in the trading post to purchase all day.

We are equipped to accept cards and cash in the trading post.

Event Patches

Event Patches will be made available in the Council Office after the event. Due to late registrations, patches were not ordered ahead for this event.

DO NOT BRING

- Pets (other than licensed service animals)
- Personal firearms and archery equipment
- Personal watercraft
- Tobacco products, including Vape pens
- Illegal drugs and alcohol
- Fireworks
- Chainsaws

COWBOY ACTION SHOOTING PROGRAM

PARTICIPATION AND HOLD HARMLESS AGREEMENT

Inland Northwest Council will be conducting a Scout cowboy action shooting program. In this program, Scouts will shoot a rifle, pistol, and shotgun under the supervision of an NRA Range Safety Officer and NRA certified instructors. Scouts will be required to wear eye protection and hearing protection at all times while on the range. Scouts are expected to abide by all safety rules and the instructions of the Range Safety Officer(s) and rifle, pistol, and shotgun instructor(s).

I, the undersigned, give my child, _______, permission to participate in this program. I understand that participation in the activity involves a certain degree of risk. I have carefully considered the risk involved and have given consent for my child to participate in the activity. I understand that participation in the activity is entirely voluntary and requires participants to abide by the rules and standards of conduct. I release the Boy Scouts of America, the local council, the activity coordinators, and all employees, volunteers, related parties, or other organizations associated with the activity from any and all claims or liability arising out of this participation.

For safety, my child and I agree that he/she will do the following or he/ she will be removed from the program. I understand that any additional cost associated with participation in this program will not be refunded if my child is removed for not following the rules below.

- 1. Complete a range safety briefing.
- 2. Wear all safety gear at all times while on the range.
- 3. Follow all the safety rules provided in the briefing.
- 4. Follow the instructions of the Range Safety Officer(s) and rifle, pistol, and shotgun instructor(s).
- 5. Do not handle the firearms until instructed to do so by the instructor(s).
- 6. <u>Is 14 years of age, or 13 and has completed the eighth grade</u>, as of the start of the class and will be in full compliance with all local, state, and federal guidelines, including age restrictions and original equipment manufacturer standards.
