Further I promise and agree as follows.

to the horse, property, and equipment involved and to the individuals undertaking such
activity.

I further understand and agree that any horse, irrespective of its training, past behavior, and characteristics, may act or react unpredictably at any time.

With full awareness of the preceding, I knowingly and voluntarily participate in the *Activities* and accept the possibility of injury to myself and my horse and other property as a risk inherent in the *Activities*.

In Consideration of my being permitted to participate in the *Activities* and for other good and valuable consideration, the receipt and sufficiency of which I now acknowledge, I agree to hold harmless of all *Parties*. Further I promise and agree as follows.

## 1. Warranties and Representations

1.1 I understand that <u>horseback riding</u>, training, and lessons is a rigorous activity and is physically and mentally demanding. I now warrant and represent that I have the requisite physical fitness and mental alertness to enable me to participate in the *Activities*. I further warrant and represent that I am in good health and free from injury, illness, disease, or other defects which may impair my ability to engage in the *Activities*.

acknowledge my responsibility to obtain inoculation and maintain protection against tetanus, a disease endemic to horses.

- 1.3 If I am boarding or using a horse owned by me or any acquaintance (and not by **Driftless Equestrian, LLC**) in connection with *Activities*. I warrant and represent that such horse has the proper temperament and health for the *Activities*.
- 2. Release I, at this moment, release and forever discharge **Parties** and their landlord (**Top of the World Stables**) for the horse barn and riding building. Pastures and all of their successors and assigns of the preceding parties (*collectively, the "Release"*) from any liability for any losses, claims demands, actions, causes of action, damages, cost, and expenses which I may herein after incurring on account of any loss, damage or injury (including death) to my person, horse or my other property, or the consequences thereof, which result from any accident, transaction, event, circumstance, occurrence, act or omission connected with or arising from the Activities, whether caused by the negligence of Release or otherwise.
- 2.1 I release, at this moment, <u>release</u> and <u>forever discharge</u> **Parties** <u>from any harm, injury or even death</u> that may result from participating in the **Activities** and in connection with the lesson horses provided by **Driftless Equestrian, LLC**.
- 3. <u>Intent</u> The release contained in paragraph 2 above is intended to be broadly consumed to release releasee's from all claims whatsoever arising out of any accidents, transaction, event, circumstance, occurrence, act, or omission, including without limiting the generality of the language in paragraph 2 above any loss, damage or injury (including death) incurred while I or my horse; other property engaged in the *Activities*, whether such loss, damage or injury arises as a result of the actions or omissions of Releases, a third party, a horse or other animal, an act of God or a combination thereof.
- 4. <u>Indemnity</u> I, at this moment, agree to indemnify, defend and hold harmless Releases. Each of them, from and against any claims, damages, costs, expenses, or liabilities that may occur due to any accident or injury caused by me, the horse of my other property, while engaged in the *Activities*.

#### 5. Miscellaneous

- 5.1 This agreement shall be binding upon and insured to benefit my heirs, successors, assigns, and legal representatives.
  - 5.2 This release shall be governed by and construed by the law of the state of Wisconsin.

## 6. Medical Treatment/Emergency

- 6.1 In the event that I require medical care or treatment, I agree to be financially responsible for any cost incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.
- 7. Horse Temperament, Training and Suitability for Rider.
  - 7.1 While the Driftless Equestrian, LLC and Instructors working on behave of Driftless

**Equestrian LLC** will make reasonable efforts to evaluate horses suitability for rider, neither party can guarantee that the horse selected for the rider will be suited for the riders skill level or safe for the rider to handle. Horses are large flight animals that have an autonomy of their own, and even horses with a high level of training can act unpredictably and unexpectedly.

- 7.2 I release, at this moment and forever discharge *Parties* from any injury or death that may result from the unpredictability of riding lesson horses provided by **Driftless Equestrian**, **LLC**.
- 7.3 I acknowledge and take full responsibility for the unpredictability of the lesson horse that I will be riding. I further understand that no guarantee of the animals training, temperament or behavior can ever be made nor will I hold **Driftless Equestrian LLC** or their **Instructors** to any guarantee or representation of the lesson horses.
- 6. Notice A person who is engaged for compensation in the rental of equines or equine equipment or tack or in the instruction of a person in the riding or driving of an equine or in being a passenger upon a horse is not liable for the injury or death of a person involved in equine activities resulting from the inherent risks of equine activities, as defined in section 895.481 (1) (e) of the Wisconsin statutes.
