

Campership Form - Application for Financial Assistance

Financial assistance is available for Cub Scouts, Scouts BSA, Venturers and Explorers who wish to attend the L.E. Phillips Scout Reservation. The Council Outdoor Committee will make every effort to honor requests, however, funds are limited.

Financial Assistance Requirements:

1. The youth must be a registered member of the Boy Scouts of America and reside in the jurisdiction of the Chippewa Valley Council.
2. Financial assistance is for Scout families that demonstrate a need for financial assistance or the scout would not be able to attend camp. Reasons why this camp fee can not be afforded must be stated below in detail. **Just because you have more than one youth in scouting is NOT a reason to apply for Financial Aid.**
3. The youth's family and/or unit must be prepared to pay at least 50% of the fee.
4. The deadline for submission is May 1st.
5. **The form must be filled out in its entirety or it will not be considered.** Any incomplete forms will be returned to applicant for completion before being considered.
5. All information provided is kept confidential. Assistance can be granted only once in a twelve month period to a scout.
7. **This form must be filled out by the family requesting assistance**
8. **This form may not be changed or modified from this original format.** Only this updated version of the Campership Form will be accepted.
