There will be no refunds after this date due to the fact that supplies will have been ordered.

Welcome to the Fall Camporee. The Tallahassee Rifle and Pistol Club (TPRC) and Troop 44/45 have worked hard on this event. This weekend you will learn Firearms Safety, Experience 22 Rifles, Shotgun (Trap and Sporting Clays), Black Powder Rifles and Cowboy Action shooting on Saturday morning and generally have a Shooting Good Time. Other Competitions will be Best Campsite Gateway, Best Campsite and Best Dutch Oven Dessert (Scout and Adult categories). On Sunday after worship services, there will be several demonstrations set up for you to look at and ask questions.

At the end of this guide there are several forms that need to be filled out for each person attending. Please take time to do so and have the paperwork ready to <u>turn in upon arrival</u>.

The TRPC ranges will be considered as HOT at all times during this camporee and will open back up for the TRPC membership on Sunday at 9am. This means that no one is permitted on the actual Firing Ranges without permission. There will be no shooting allowed other than the posted shooting times on Saturday.

Come out and enjoy the weekend with us. The TRPC will be providing lunch for registered camporee attendees only on Saturday.

#### **Check-in Procedure**

Your troop should plan to arrive at TRPC (see attached map) between 4:00 and 8:00 pm on Friday. No one will be allowed into camp prior to 4:00 pm. When you arrive at TRPC, all vehicles will be able to go to their campsite and unload, then will be directed to the parking area. Parking will be limited so please carpool to the site. The Scoutmaster or his designees and the Senior Patrol Leader should then go to the Administration Tent for the check-in process.

#### **Check-Out Procedure**

Check-out will begin On Sunday after Church Service. Remember, there will be Demonstrations on Sunday if you choose to stay. If your troop needs an earlier check-out time please let us know when you check In Friday.

The Staff will come by your campsite to inspect prior to your departure. Patches will be given to you at that time.

You will then be allowed to drive into camp to collect all gear.

### Camporee Rules

- Every troop must maintain two-deep leadership at all times.
- Personal firearms, ammunition and archery are not to be brought to camp.
- No fireworks, alcoholic beverages or illegal drugs are allowed in camp.
   Possession of these will be grounds for dismissal from camp without a refund.
- The proper BSA uniform is to be worn at all times. This means the Field
   Uniform is to be worn at flags. The activity uniform should be worn the rest of the time.
- Vehicles must be left in the parking lot at all times.
- Everyone coming in to or leaving the Camporee must check in and out at the Administration Tent.
- No open toe shoes are to be worn at the camporee.
- The parking lot is the designated smoking area. Smoking is not allowed in camp.
- All scouts and leaders MUST have a current BSA health form and registration to participate in camp.
- Scouts and leaders should abide by the Scout Oath and Law and the Guide to Safe Scouting.
- All Youth Shooters must complete the TRPC Youth Waiver form found in this Guide and on the registration page
- Only Scouts BSA, Venturers and Adults may be on the firing ranges or shooting. There is NO Cub Scout shooting available at this event.

### AGREEMENT, RELEASE, INDEMNIFICATION, COVENANT NOT TO SUE, AND WAIVER OF LIABILITY

(PLEASE READ CAREFULLY BEFORE SIGNING)

The undersigned agrees to abide by all Range Safety Rules, General Range and Club Rules, and Standing Rules of Tallahassee Rifle and Pistol Club, Inc. (TRPC), and the undersigned represents that he or she understands all of these rules, and was given the opportunity to ask for clarification of any of the rules before signing this Agreement. The undersigned understands that TRPC reserves the right to eject from the property and the premises any individual who violates any of the Range Safety Rules, General Range and Club Rules, and/or Standing Rules of TRPC or otherwise acts in any unsafe manner as determined by TRPC. The undersigned agrees to peaceably leave the property and the premises of TRPC if so ejected.

The undersigned understands that any nonmember of TRPC who is not accompanied by a member of TRPC is trespassing, and subject to legal Action. The undersigned further understands that trespassing with a firearm is a felony pursuant to the Florida Statutes. Additionally, the undersigned understands that any possession of a firearm by a person convicted of a felony or convicted of a misdemeanor crime of domestic violence is a serious crime prohibited by Federal law and/or Florida law, and that TRPC will cooperate fully with any and all Federal and State authorities with the investigation and prosecution of such crimes.

In consideration of the acceptance of my participation and/or the participation of my child or ward, directly or as a spectator, observer, range officer or safety officer, in any activity, class, lesson, competition, demonstration, use of any firearm range(s) and/or facilities, use of any air gun range(s) and/or facilities, use of any clay target range(s) and/or facilities, use of any action range(s) and/or facilities (including structures located thereon), use/rental of any firearm, use of the clubhouse, or any other use of any of the facilities whatsoever of TRPC (hereinafter, collectively, "Activity"), THE UNDERSIGNED AGREES TO ASSUME THE RISKS incidental to such participation and, on my own behalf, on behalf of my child or ward, and on behalf of my and my child's or ward's heirs, executors and administrators, I RELEASE, INDEMNIFY, HOLD HARMLESS, COVENANT NOT TO SUE, AND FOREVER DISCHARGE the Released Parties defined below, of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my participation and/or the participation of my child or ward in any such Activity. The Released Parties are Tallahassee Rifle and Pistol Club, Inc; its members, shareholders, officers, directors, employees, range masters, volunteer workers, independent contractors, agents, representatives, attorneys, insurers, successors and assigns; and its parent, related, affiliated and subsidiary companies. The undersigned expressly understands that the Release, Indemnification, Covenant Not to Sue, and Waiver of Liability provisions of this Agreement clearly and unequivocally include and apply to any claims based on the negligence (whether active or passive), ownership of any dangerous instrumentality, ownership of the premises, action or inaction of or by any of the above Released Parties, including, but not limited to, claims for bodily injury, death and property damage or loss suffered by me, my child or ward as a result of such participation in any Activity. Additionally, the undersigned further agrees to indemnify and hold the Released Parties harmless from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my participation and/or the participation of my child or ward in any Activity which results in the personal injury or death of anyone whatsoever, or loss or damage to the property of anyone whatsoever (including the loss of use thereof).

This Agreement shall be governed by the laws of the State of Florida, and any legal action arising out of participation by myself, my child or ward in any Activity, or any litigation relating to the enforcement of this Agreement shall be

commenced exclusively in either the Circuit Court of the Second Judicial Circuit in and for Leon County, Florida, or the County Court in and for Leon County, Florida, as appropriate.

In entering into this Agreement, I hereby grant the Released Parties a limited power of attorney and authorization to obtain, at my cost, any and all emergency medical treatment that may be needed by myself, my child or ward as a result of participation in any Activity. For the purposes of this Agreement, emergency medical treatment means medical care or treatment necessitated by a sudden, unexpected situation or occurrence resulting in a serious medical condition demanding immediate medical attention. However, I release, indemnify, hold harmless, covenant not to sue, and forever discharge the Released Parties of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with the exercise or the failure to exercise such limited power of attorney and authorization, whether negligent or otherwise.

I expressly agree that this Agreement is intended to be as broad and inclusive as permitted by law, and that if any provision of this Agreement is held illegal, invalid, or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby, and such invalid part, term or provision shall not be deemed part of this Agreement. I further agree that any ambiguities in this Agreement shall not be construed in favor or against any party by virtue of that party having drafted the Agreement. No remedy conferred by any of the specific provisions of this Agreement is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder shall not constitute any waiver of the right to pursue other available remedies.

#### NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF TRPC USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM TRPC IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND TRPC HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

I certify that I am eighteen (18) years of age or older and that I am entering into this Agreement on my behalf and/or as parent or guardian of a child or ward under the age of eighteen (18). I further certify that I have received permission from the parent or other legal guardian of any child or ward accompanying me (who is not my child or legal ward) to allow such child or ward to handle and discharge firearms, and that I am authorized to enter into this Agreement on their behalf. I expressly understand that the aforementioned Activity may include the discharge of firearms and the firing of live ammunition. I agree that I (and any child or ward accompanying me) will wear appropriate eyesight and hearing protection at all times while on any firing range. I further certify that I have completely read the foregoing and I expressly agree to all of the provisions of this Agreement.
