

Countries exempt from eTA -

Citizens of Kenya and East African Partner States are exempt from completing the eTA. The East African Partner State countries include Burundi, Democratic Republic of Congo, Rwanda, South Sudan, Tanzania and Uganda.

## Start your trip to Kenya



### **Tourists & Visitors**

Choose this option if you are visiting Kenya for tourism, business, or visiting for any other reason to apply for your travel authorisation.



Choose this option if you are a citizen of Kenya or an East African Partner State.

These countries include Burundi, Democratic Republic of Congo, Rwanda, South Sudan, Tanzania and Uganda.

#### How to Apply

All visitors including infants and children who intend to travel to the Republic of Kenya must have an approved Electronic Travel Authorisation (eTA) **before** the start of their journey.

#### Persons who are exempt from obtaining the Electronic Travel Authorisation (eTA)

- Holders of valid Kenya Passports or one-way Emergency Certificate issued by Kenya Missions abroad.
- 2. Holders of Kenya Permanent Residence, valid Work Permits and Passes.
- 3. Holders of valid Kenya eVISAs
- 4. Holders of valid United Nation Conventional Travel Document issued by the Government of Kenya.
- 5. Members of the Diplomatic Missions and International Organisations Accredited to Kenya (exempt from payment only).
- Citizens of the East African Partner States; These countries include Burundi, Democratic Republic of Congo, Rwanda, South Sudan, Tanzania and Uganda. (Exempted for Six (6) months)
- 7. All passengers in transit through Kenya arriving and leaving by the same aircraft or transferring to another aircraft and who do not leave the precincts of Airports in Kenya.
- 8. All passengers arriving and leaving by the same ship, and who do not leave the ship.
- Members of crew of any ship, aircraft, train, vehicle or carrier; whose name and
  particulars are included in the crew manifest of the ship, aircraft, train, vehicle or carrier;
  and who is proceeding in such ship, aircraft, train, vehicle or carrier to a destination
  outside Kenya.
- 10. Owners of private aircraft stopping over for refuelling in Kenya and who do not leave the precincts of the airport.

Please have the following documents ready before starting your application.

#### For all travelers

- Valid passport for at least six (6) months after your planned date of arrival into Kenya, with at least one blank page
- Selfie or passport-type photo
- Contact information, email address and phone number
- Details of your arrival and departure itinerary
- Accommodation booking confirmation(s)
- Credit card, debit card or other means of payment

#### Based on your country of residence and citizenships the following may also be required:

Financial assets / banks letter(s)

### An invitation letter - this will be provided by Savage Wilderness, the location for Camp Kenya 2024

Vaccination(s) or test results certificates may be needed for travelers from some countries.

Processing time is three (3) working days but in some cases it may take longer.

If you are a family, a couple, friends living together or a company submitting on behalf of your employees, you can save time by applying as a group. To apply as a group, you must meet certain eligibility requirements.

Group application -

Eligibility Checklist for Group Applications

If you are a family, a couple, or friends travelling together in a group of up to six (6) travellers, you can save time by applying together.

Select the "Group Application" option on the eTA website or mobile app and follow the instructions. On approval, each member of the group will receive their own Electronic Travel Authorisation. If there are more than 6 travellers in your group, please apply as 2 or more groups.

All individuals in the group application must:

- Share the same country of residence.
- Share the same purpose of visit to the Republic of Kenya.
- Share the same travel and accommodation itinerary for their entire trip to and stay in the Republic of Kenya.

Each eligible traveller is required to have an eTA before starting travel. It is mandatory to use the Government's official website to submit your application. Applications submitted via third party websites will be automatically denied. For children under the age of 18, the legal guardian, parent or accompanying adult is responsible for filling the application.

The single entry eTA fee is USD 32.50 per traveller, plus bank and processing fees.

The multiple entry eTA fee is USD 160 per traveller, plus bank and processing fees.
