**Scouting Participation and Hold-Harmless Agreement (Bring to the Event)**

Scouts will be instructed how to safely handle, maintain, and shoot one or more of the age/program appropriate activities listed below and be provided instruction to increase their skills. Scouts will have classroom instruction and range instruction in which they will participate under the supervision of trained BSA Range Master, USA Archery Level 1 or higher certified Archery Instructor, NRA RSO, NRA firearm specific instructor, as required by BSA policy (required supervision).

Scouts will be required to wear applicable arm-guard and finger tabs, eye and hearing protection while on the range as required by BSA policy.

Scouts are expected to abide by all safety rules and the instructions of the qualified supervision.

I have carefully considered the risk involved and have given consent for my child to participate in the activity. I understand that participation in the activity is entirely voluntary and requires participants to abide by the rules and standards of conduct. 5. Do not handle any equipment until instructed to do so by the qualified supervision
6. Is registered as a Cub Scout, Boy Scout, Sea Scout, Venturer, or meet the required age guidelines to participate in a recruiting event.

I understand that any additional cost associated with participation in this program will not be refunded if my child is removed due to behavioral problems.
